IN FY 2024-2025, NORTH SHORE HORIZONS PROVIDED CRISIS INTERVENTION, OUTREACH/EDUCATION, ADVOCACY, LEGAL ASSISTANCE, AND CASE MANAGEMENT SERVICES TO 1,277 ADULTS AND CHILDREN. "I NEEDED THE SUPPORT. JUST MENTALLY MY SELF-ESTEEM AND DEPRESSION KEPT ME FROM MAKING GOOD CHOICES. I WAS DESPERATE WITH NOWHERE TO GO.
