#### **POLICY RESOLUTION**

# AMENDING RULES AND REGULATIONS REGARDING PETS

WHEREAS, pursuant to the Association's By-Laws the property, affairs and business of the Association shall be managed by the Board of Directors, which shall have all those powers granted to it by the Certification of Incorporation, the Master Deed, (the) By-Laws, and by law; and

WHEREAS, the Governing Documents of the Mountainview Manor Condominium Association, Inc. at Article VI, Section 1 (Sic) of the Bylaws empower the Board to promulgate rules and regulations for the health, benefit and welfare of all members of the Mountainview Manor Condominium Association, Inc.; and

WHEREAS, the New Jersey Condominium Act at N.J.S.A. 46:8B-14(j) states that the Association, acting through its Board of Directors shall exercise its powers and discharges its functions in a manner that protects and furthers the health, safety and general welfare of the residents of the community; and

WHEREAS, the New Jersey Condominium Act at N.J.S.A. 46:8B-14 (c) states that the Association, acting through its officers or governing board, shall be responsible for the performance of the adopting, distribution, amendment and enforcement of rules governing the use and operation of the Condominium and the Condominium property and the use of the Common elements; and

WHEREAS, the Board of Directors has determined that it is in the best interest of the health, safety and general welfare of the residents of the community to implement certain Rules and Regulation; and.

WHEREAS, By Resolution adopting certain rules and regulations recorded on June 8, 1998 in the office of the Morris County Clerk in Deed Book 4777 Page 269, The Board of Directors adopted rules and regulations which prohibited all pets except for birds, fish, and up to two cats to be housed within any unit. All other pets including dogs, were strictly prohibited; and

WHEREAS, the Board of Directors deems it desirable and in the best interest of the membership to amend this rule to permit unit owners to additionally house one dog within their units as a pet, subject to the restrictions set forth herein.

NOW, THEREFORE, BE IT RESOLVED THAT the following policy regarding pets is hereby adopted:

- 1. Unit owners may harbor the one dog which does not exceed 25 pounds within their unit.
- 2. American Staffordshire Terriers or Pitbulls whether purebred or mixed breed are strictly prohibited. These breeds include, but are not limited to, American Pitbull Terriers, American Staffordshire Terriers, American Bully and Staffordshire Bull Terriers, American Bulldogs, and any other dog that has the substantial physical characteristics and appearance of these breeds.
- 3. All cats currently residing in a unit at Mountainview Manor must be registered with the Association Management Company within 30 days of mailing of this recorded Resolution to the Membership. All dogs and cats obtained after mailing of this recorded Resolution to the Membership must be registered with the Association's Management Company within 30 days of obtaining the animal.
- 4. Registration shall include submission of the pet's name and sufficient identification of the breed, size and color of the pet for Association identification purposes. It must also include documentation of licensing with the municipality and proof from a veterinarian of all required vaccines.
- 5. Any animal with a history of aggressive behavior is prohibited. The Association reserves the right to require removal of any animal which disrupts the quiet enjoyment of other residents (for example through excessive barking) or displays any vicious or threatening behavior.
- 6. All pets must be leashed when outside of the unit and may not be left unattended.
- 7. All pets must be leashed when transported through any common areas.
- 8. Pets are not permitted to roam the property.
- 9. Dogs must be walked on paved areas only or other areas designated by the Board of Directors.
- 10. All solid waste must be immediately picked up and disposed of properly.

11. Residents shall take whatever steps are necessary to insure that their pets do not make excessive or untimely noise.

- 12. No bird houses and/or feeders are permitted anywhere in the community.
- 13. All pets which the Township of Rockaway requires to be licensed must be so licensed. Tags are to be worn at all times.

BE IT FURTHER RESOLVED THAT enforcement of this Resolution shall occur in accordance with the procedures established by the Association with regard to due process. Pursuant to the Association documents, the Board shall have the power to levy fines against any owner who fails to comply with the terms of this Resolution. Collection of fines may be enforced against any owner as if the fine were a common expense, and such fines shall constitute a Lien upon the subject unit.
