### CURRENT FEES

#### 1. ON-SITE VISITATION FEES

##### Observational

- \$40.00 per hour, up to three children and one adult (2 hr. min)
- \$10.00 per hour, per additional child over three (2 hr. min)
- \$25.00 in addition per hour, if recorded (2 hr. min)

##### Documented

- \$50.00 per hour, one child and one adult (2 hr. min)
- \$60.00 per hour, two children and one adult (2 hr. min)
- \$70.00 per hour, three children and one adult (2 hr. min)

#### 2. OFF-SITE VISITATION FEES

##### Observational

- \$60.00 per hour, up to two children and one adult (2 hr. min)
- \$20.00 per hour, per additional child (2 hr. min)

##### Documented

- \$70.00 per hour, one child and one adult (2 hr. min)
- \$80.00 per hour, two children and one adult (2 hr. min)
- \$90.00 per hour, three children and one adult (2 hr. min)

#### 3. LICENSED PROFESSIONAL VISITATION FEES

- \$150.00 per hour for one child and one adult (2 hr. min)

#### 4. FACILITATIVE PROFESSIONAL VISITATION FEES

- \$200.00 per hour for one child and one adult (2 hr. min)

#### 5. THERAPEUTIC VISITATION FEES

- \$250.00 per hour for one child and one adult (2 hr. min)
- \$25.00 post visit documentation per visitation

#### 6. ON-SITE SUPERVISED EXCHANGES

##### Direct

- \$20.00 per exchange

##### Escorted

- \$30.00 per exchange

### 7. OFF-SITE SUPERVISED EXCHANGES

Direct

- \$40.00 per exchange

Escorted

- \$60.00 per exchange

### 8. ADDITIONAL FEES

- \$80.00 initial administrative fee to establish services
- Additional fees apply for more than one adult
- Additional fees apply for more than three children
- \$35.00 per hour for each additional supervisor required
- \$1.00 per mile for fuel if the visitation site is more than 10 miles outside of a center location
- \$250.00 per court report
- \$50 per hour per incident for case management
- Additional fees apply for any extra administrative fees
- Out of Area Visits – to be determined on a case-by-case basis
- \$50.00 per schedule change for a previously scheduled visitation or exchange

### 9. REQUIREMENTS

- Full payment of the visit or exchange is due by 5:00 p.m. two business weekdays prior to the visit.
- The canceling party will incur the full fee of the visitation or exchange if they fail to notify BTH-DS of cancellation by 5:00 p.m. the weekday preceding the visit.
- If both parties fail to appear for the visit or exchange, each will be responsible for 1/2 the full fee of the visitation or exchange.
- If the parent picking up is more than 10 minutes late, they will be responsible for
- All outstanding balances are due prior to scheduling further visits or exchanges.
- If the custodial parent is more than 10 minutes late for drop-off or pick-up, a \$1.00 per-minute charge will be assessed until arrival and is payable by the custodial parent, plus an hourly rate of \$200 for any late pick-up over 30 minutes, rounded to the nearest 15 minutes. Anything over 1 hour will be considered abandonment, and the appropriate authorities will be contacted.

### 10. PAYMENT

- One of the ways in which BTH-DS maintains neutrality and ethical practice is by assuring that fee payment is not contingent on a particular recommendation or outcome. As such, fees are due in advance. Payment must be made through the following link: <https://childreninthemiddle.com/payment>
