**ORDER FOR SUPERVISED EXCHANGES**

IT IS ORDERED that all exchanges between the petitioner, \_\_\_\_\_ and the respondent, \_\_\_\_\_ for the child(ren) in the above-styled cause shall occur under the supervision of Between Two Homes-Direct Services, or a representative of Between Two Homes-Direct Services (the “supervising agency”). The parties are ORDERED to fully complete all required forms and information located at [childreninthemiddle.com/supervised-parenting-time](http://childreninthemiddle.com/supervised-parenting-time) and submit the forms to [intake@betweentwohomes.com](mailto:intake@betweentwohomes.com) within (3) days of the signing of this order. The parties are ordered to attend the orientation appointment, appear at and participate in orientation, and comply with the supervising agency's guidelines and requirements as directed. The parties are ORDERED to cooperate with the supervising agency and abide by any instructions provided by the supervising agency within the program guidelines, including terminating a supervised visitation session if the parties do not comply with the required guidelines.

**Exchanges (check one):** IT IS ORDERED that the parties will ( ) directly exchange the child/ren in the presence of and at the instruction of the exchange supervisor, or ( ) deliver the child(ren) to the supervising agency, and the exchange supervisor will escort the child(ren) between parties.

**Other Individuals (check one):** IT IS ORDERED that ( ) no other adults or children may be present at the exchanges, or ( ) any other adults or children brought to the exchange are to remain in the vehicle prior to, during, and after the entire exchange process.

**Times and dates:** IT IS ORDERED that the supervised exchanges shall be scheduled by the supervising agency as close to the following days and times as is practicable, based on the supervising agency’s availability to schedule such exchanges:

IT IS ORDERED that any such transporting person shall e-mail [intake@betweentwohomes.com](mailto:intake@betweentwohomes.com) the fully completed required forms and information located at [childreninthemiddle.com/supervised-parenting-time](http://childreninthemiddle.com/supervised-parenting-time) by 5 p.m., not less than two business weekdays prior to attending any supervised exchange.
