ORDER FOR SUPERVISED VISITATION

IT IS ORDERED that all contact by _____ with the child(ren) in the above-styled cause shall occur under the supervision of Between Two Homes-Direct Services, or a representative of Between Two Homes-Direct Services (the “supervising agency”). The parties are ORDERED to fully complete all required forms and information located at childreninthemiddle.com/supervised-parenting-time and submit the forms to intake@betweentwohomes.com within (3) days of the signing of this order. The parties are ordered to attend the orientation appointment, appear at and participate in orientation, and comply with the supervising agency's guidelines and requirements as directed. The parties are ORDERED to cooperate with the supervising agency and abide by any instructions provided by the supervising agency within the program guidelines, including terminating a supervised visitation session if the parties do not comply with the required guidelines.

Form of Supervision: IT IS ORDERED the supervised visitation will be

- Observational- No documentation except sign in/out or concerns
- Documented- Document at least every five minutes
- Professional- Document at least every five minutes by a degreed professional in the field of education, mental health, or security
- Facilitative- The supervising agency is a Master's level degreed individual in the field of education or mental health. The purpose of facilitative supervision is to promote positive and healthy engagement.
- Therapeutic- This supervision is a specialized form of supervised parenting time that combines visitation oversight with clinical intervention provided by a licensed mental health professional.

Exchanges (check one): IT IS ORDERED that the parties will () directly exchange the child/ren, or () deliver the child(ren) to the supervising agency supervisor to escort the child(ren) between parties.
