## Parent Child Success LLC Policies, Procedures and Payment

## **Appointments:**

- 1. Group therapy is held at Jupiter Pediatric Associates and occur on a weekly basis. Therapist will notify group therapy participants of a change to group therapy day, time, location, and/or cancellation when necessary.
- 2. Individual therapy sessions may occur in the client's home, school, clinical setting or community location as determined by the needs of the client and therapist recommendation.
- 3. Cancellation of an individual therapy appointment must be made a minimum of 24 hours prior to scheduled appointment.
- 4. Individual therapy sessions are now offered as 4 session packages. One cancellation (made 24 hrs prior to scheduled appointment) and re-schedule will be permitted per package. Therapy package must be paid in full prior to receiving services.
- 5. Group therapy sessions may be purchased as a 4 session package or a single session. The group therapy participant may use the 4 sessions over a 6 week period.
- 6. Cancellations made less than 24 hours prior to scheduled appointment are considered a "Late Cancellation" and client will be charged a \$50 late cancellation fee to the credit card on file.
- 7. If a client is a "No-Show" to a scheduled appointment, the credit card on file will be charged for the full amount of the service that was to be rendered.
- 8. Consistent cancellations and/or no-shows may result in termination of services by therapist.
- 9. Any calls, texts, or emails sent after 5:30 pm will be returned after 9:30 am the following business day, unless otherwise scheduled by therapist.

## Payment:

- 1. I agree to pay Parent Child Success LLC for all services rendered.
- 2. Parent Child Success LLC reserves the right to change the rates of services, in which case clients will be notified prior to receiving services.
- 4. Client credit card is required to be on file in case of a no-show or late cancellation.
- 4. Accepted payment methods include credit card, Venmo and Zelle.
- 5. Rates for service are as follows:
  - Occupational Therapy Evaluation
    - \$450/ 1 hr (provided in client's home; includes administration of standardized assessments, non-standardized assessment, clinical observation, and written evaluation report)
  - Pediatric Feeding Therapy
    - \$800/4 1 hr session package (provided in the client's home)
    - Client will be charged for food purchased by therapist for therapy sessions

- Individual Pediatric Therapy 1 Hr (provided in the client's home, school or community location)
  - \$800/ 4 session package
- Parent Coaching
  - \$800/4 session package (provided in the client's home)
- Individual Trauma-Informed Yoga Therapy (provided at Kula Yoga Shala in Jupiter, FL)
  - \$1,000/4 1.5 hr session package
  - \$800/4 1 hr session package
- On-Call Therapy Appointment (less than 24 hrs notice)
  - o \$350/1 hr
- Group Therapy
  - Teen Girls Anxiety Group \$300/4 sessions; \$100 for single session
  - Women's Anxiety Group \$200/4 sessions; \$75 for single session
- School Consultation
  - \$1,000 (includes 1 hr in-school observation, written report of findings, email/phone call correspondence with teachers/administration, and a 1 hr in-person follow up meeting with school staff)
- Phone Calls \$25 per 10 minutes (card on file will be charged)
- Travel Fee \$100 (for appointments outside of Northern Palm Beach County)
- Referral Credit
