

Associated Lock Forensics Application

Our Purpose – ALF is formed to create a group of expert locksmiths and Safe consultants in one place to pool our resources and experience for attorneys, insurance companies, etc. to find investigators and certified lock, door, and safe experts to serve the legal community in litigation.

How does it work? Apply to become an Associate Members by filling out this application. Once your application is approved, ALF will list you as an "Associate Member" on our website for prospective clients to review. The Acting Board Members will decide in priority which associate will be offered the job. The associate will have 24 hours to accept before it is offered to another associate. Member Associates are basically subcontractors (not employees) of ALF with no voting rights. Each associate will need to sign an Associate Consultant Agreement after their application is approved dictating the terms and conditions of their subcontract with ALF. All fees to be charged to clients shall be based on a minimum of \$350 per hour or a higher negotiated rate. Billing and invoicing of the client will be handled through ALF. Associates will receive income from services rendered through ALF as a subcontractor at the agreed upon hourly rate with the client. ALF will charge client a separate referral fee for it's services.
