

## Wellness Grant

Have A Need A Ministry encourages communities of sharing, and this grant is an opportunity for the individual applicant to initiate a circle of sharing. The mission of this grant aligns with Have A Need A Ministry's mission to promote and support local community members sharing and receiving free items, information, events, employment opportunities, volunteer support, and other resources.

## The goal is multi-faceted sharing:

- 1. Enhance the health and wellness of the individual through trying day-to-day products like large stores (Walmart, BJs, Target, Costco) that carry health and wellness products, personal care products for adults and children, beauty products, cleaning products, laundry products, personal and home safety services, and much more.
- 2. A nonprofit organization or an individual can gain monthly revenue that can build over time. For a nonprofit, this effort is minimal as an individual helps build the membership under the organization. An assigned individual is the director to continue to help residual revenue grow and encourage others to become Wellness Company members.
- 3. For an individual, it is an opportunity to gain some extra revenue and build their role in the Wellness Company as a product marketer.
- 4. This means the nonprofit can have non-restricted revenue that can be used for anything and an individual can add some extra cash to offset their living expenses or help them with projects.

## The individual can benefit from:

- 1. Agreeing and the initial registration month and committing to 3 months of membership to a Wellness Company with reimbursement grant funds to cover the initial pack purchase and up to 3 months of products<sup>1</sup>.
- 2. Identifying and signing up a nonprofit<sup>2</sup> or a committed individual<sup>3</sup> as a recipient of residual income from the effort.
- 3. Signing up a minimum of 4-10 additional individuals willing to participate with the Wellness company for a minimum of one month.
- 4. Consider the provision of ongoing support to the nonprofit and the individual beyond the 3-month minimum.

Applicant deadline is based on a first-come first-served basis of eligibility. Notification of acceptance will be within 5 days of application.

- 1. Agree to a 30-minute Zoom Meeting for preparation and explanation.
- 2. Fill out the Have A Need A Ministry Wellness Grant Application
  - a. including proof of Florida residency,
  - b. proposed nonprofit (501(c) 3 or support with a pre-approval agreement,
  - c. explanation of viable credit/debit card to activate membership to the



Wellness company, and agreement to provide receipts for first 3 months (90 days) of purchases. Reimbursements can be provided via direct deposit (3-5 days) or mailed check (7-10 days).

Explain in 250 words or less explain why -

- wellness products are important to you and those you care about,
- this grant is viable to apply for you as an individual,
- what elements of the nonprofit's and/or the individual's needs can be met.

## Final requirement:

Provide a confirmable list of 15-20 individuals (no contact information required, only first initial and last names) that you would be willing to contact to support this effort should you be awarded the grant.

<sup>&</sup>lt;sup>1</sup>Varies based on available resources of the HANA nonprofit, but will fund some if not all products for three months.

<sup>&</sup>lt;sup>2</sup>Per the standards for 501(c) organizations, any gained funding from the Wellness Company that exceeds \$1,000 in one taxable year is Unrelated Business Taxable Income (UBTI) unless the effort aligns with the organization's mission and normal activities. Nonprofits can accept taxable income within certain limits. This information can be explored with the legal counsel and/or accountant of the nonprofit. This effort is worth it if the funds are not the sole funding of the organization.

<sup>&</sup>lt;sup>3</sup>The revenue is taxable. If an individual receives any income that exceeds \$600 in a tax year a 1099 will be issued from the Wellness Company by January 31 of the next year.
