Manager; Freebeard (This is his complete legal name)

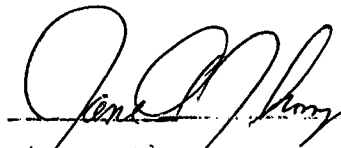
