



What is a CSA?

A Community Supported Agriculture (CSA) consists of a community of individuals who pledge support to a farm operation where the growers and consumers share the risks and benefits of food production. Our CSA is of a system of weekly pick up, at our farm, of seasonal, naturally grown fruits and vegetables.

Our 2026 CSA is expected to run 20 weeks from around beginning of June through mid- October.
