TERMS & CONDITIONS OF HIRE

- Payment of 50% of the Total Hiring Costs is payable on acceptance of Booking request. Booking will only be confirmed upon receipt of the above amount. Proof of payment to be send info@shrishivamandir.org.au
- The balance must be paid at least 7 days prior to the event's event date.
- Mandir site is a sacred site and hence its sanctity as the holy place, must be observed at all time. **Use of Alcohol, Cigarette Smoking and meat product (non Veg) are not allowed on the site.**
- **Level of Noise must be kept low as not to inconvenience surrounding residents.**
- **Mandap, DJ or sound system are not allowed in the Mandir Hall. A flowerily decoration is only allowed around the wedding area. Please discuss details with the Mandir's Management.**
- Use of Chairs are allowed in the Mandir Hall with prior discussion and approval from Management. All items must be stowed away safely after use.
- Ceremony event is to be completed within 4 hours. Any event extending into the Mandir's closure time, will have an additional charge at the rate of \$500.00 per hour.
- Use of Under Cover Carport if booked, is limited to the use of table and chairs for serving food. It is the Hirer's responsibility to arrange and to stack all items after the event.
- Hirer by accepting these Terms and Conditions indemnify Shri Shiva Mandir against any claims resulting from the food prepared by third party and handling of the same.
- External priest for the Wedding Ceremony is permitted Subject to approval of the management committee and can accompany the Mandir officiating priest in the Ceremony. External priests are not allowed to do any ceremony or pooja inside the Temple Sanctum.
- All waste must be deposited in the large Bin located in the car park.
- Premises - Mandir Hall, Yagna Shala and Undercover Carport when used must be kept cleaned.
- **The costs exclude decorations, hiring of canteen area and Dakshina to priests.**
- **A bond of \$500 is to be paid at the time of the booking.**
- If the event is more than 4 hours, a fee of \$500 per hour will be charged.
- Cancellation is allowed 14 days prior to the booked date, cancellation within 14 days will forfeit the bond.
- Refund will be made by EFT to the BSB and Account number when provided within 10 business days of the end of event.
- Cancellation can only be made by email to Urmila Daya (umi_daya@hotmail.com)
- Dakshina of \$251 (minimum) to be paid to priest directly.
