

For the record, my name is Greg Befort, Mohave County Taxpayer. During my last testimony during the Call to the public, I mentioned there were three things that the Board of Supervisors needed to do to repair the loss of public trust and confidence. I got through two. Family matters do not permit me to attend in person, which I prefer.

This brings me to the third demand, which time didn't allow me to address last time. This demand was for the immediate removal of the modified RNA biological weapon masquerading as a vaccine. The same weapon that the corrupt CDC and FDA recently approved for pregnant women and infants with a .02% mortality rate from Covid-19.
