



Centre Update - Re-Opening Status

Hi Everyone,

We know many of you are awaiting news of when we can re-open. We have spoken with the local Health Unit and the situation is as follows:

Regardless of how we may feel about our service being essential (as we feel it is for many of our clients) it is not recognized as essential by the Government of Ontario and is considered a Personal Care Service which is ordered to close at this time.

Floating can only be open at this time if it is **overseen/administered** by a Regulated Health Professional (meaning that a Health Professional is on site, who by appointment is recommending the float as a treatment, and is on sight while you float). As there is currently no one on Staff who fulfils this description we are unfortunately unable to remain open at this time.

When Can We Open?

We will be able to re-open under the Grey Zone for anyone who provides a note from a Regulation Health Professional. (See Below)

Schedule 7 Businesses that may Open in Grey Zone

Under Section 22.1(1):

Personal care services

(1) Personal care services relating to the hair or body, including hair salons and barbershops, manicure and pedicure salons, aesthetician services, piercing services, tanning salons, spas and tattoo studios, may open if they comply with the following conditions:

(5.) ***Sensory deprivation pods must be closed, unless they are used for a***

therapeutic purpose prescribed by, or administered by, a regulated health professional.

This means we can re-open as long as everyone who is floating has been prescribed floating by Regulated Health Professional (Nurse, Doctor, Chiropractor, Physiotherapists, Massage Therapist, Therapist, Psychologist, Social Worker etc.)

Each customer is therefore required to provide a Regulated Health Professional Note prior too Floating while under the Grey, Red and Orange Zones.

This will only be in place while under Orange and Red Zone Restrictions, these requirements will be lifted when we return to the Yellow or Green.

Regulated Health Professional Note Requirements / Sample Note

All Notes Must Have

1. Professional Letterhead
2. Prescription/Recommendation for Floating
3. Registration Number (To Show they are supported by RHPA)
