Requirements

- **Create Your Original Piece**

It is important to remember that your art must be in the highest resolution possible to achieve the best quality print possible. Please do not submit a piece that is inspired by another artwork. As a very small charity, we cannot battle a Copyright lawsuit. So please, trust in yourself and your unique style, because we do. We recommend providing vector files as an additional option. Designs that are random brushes, splatters, and or textures with no focused subject matter or design concept are not accepted. Please design your artwork with an invisible frame around it, one that fits on the backs or fronts of shirts, totes, and other products. Do not include any vulgar or prejudiced phrases or words. Do not include any illegal items.

Colour Mode: RGB, 8-bit

File Types: JPGs, TIFFs, AI, and EPS.

Resolution: 150 DPI

Sizing: 42" x 56"

Positioning of Design: Consider where your design will be placed on products. No designs over seams.

Tax: Talk with your tax agent about covering any costs and time spent on the design(s) as Marketing Expenses or other business expenses.

Note: Do not forget that the resolution depends on your platform. If you are designing a vector (Illustrator), then resolution does not apply. Just make sure to expand your strokes and text.
