### Vendor Benefits:

- Use of gathering space and classroom for a small fee
- Monthly payouts
- Social Media presence - minimum two posts per month from the Junction

### Vendor Responsibilities:

- Manage your display at least once a week keeping it neat, clean, and attractive.
- Provide your own display stands and decor.
- Keep your display well stocked with attractive, new, family friendly products.
- Take photos of your products in the Junction and post at least once a week on Social Media promoting your products and Effingham Junction.
- Promote Effingham Junction in your social circles and on your business page.
- Uphold the standards of our community in a respectful and responsible way.

### Vendor Terms:

- \$400 per year - starting May 1, 2025
- Agreement length - six months firm - paid up front (\$200) then month to month (\$35 per month)
- 20% commission of total sales to Effingham Junction
- Sales tax will be handled at the point of sale.
- Effingham Junction will issue a check on or about the first of the month along with a detailed sales and inventory report.
