As a safety issue, please remove all Christmas lights from your home and yard. Thank you.


### COMMON AREA

fter much effort by both the previous officers, current officers and the PHOA attorney, the final piece of green space, the front entrance common ground from Sardis to Enfield, has been transferred to the Princeton Homeowners' Association. This transfer did not place in 2008 as the officers had hoped but rather in 2009. According to the Hall County Tax Office, the PHOA cannot try to place this parcel into the Trust with the other

green space until 2010. By placing this into the Trust the taxes can be greatly reduced. Previously the Phase III green space of about 25 acres had been turned over by the developer. The PHOA placed this large parcel into an agricul-

#### PRINCETON FACTS

id you know there are a total of 127 building lots in the Princeton Subdivision? This does not include the green space. And, currently there are only 11 lots that have not been developed. Most vacant lots are owned by a couple of builders, the developer and a bank.

Do you know what you can get for less than 28 cents a day? One paid year of membership in the Princeton Homeown-Association. The yearly membership dues are less than \$2.00 a week. Princeton HOA is a mandatory association as set up by the developer. Each homeowner is required to meet their obligation of yearly dues. Dues are late 60 days after notification in March.

What is the purpose of these dues? The dues pay the property taxes the common grounds. It also pays for any legal expenses the PHOA incurs. In addition to that it pays for the grounds and entrance upkeep. There are other expenses for maintainthe association. Please refer to the annual budget for a more detail breakdown. The low PHOA fee of \$100 a year is extremely reasonable. The Princeton Community is a lovely area and this fee helps to maintain the appearance.
