FINANCIAL REPORT

The HOA balance is looking strong. Most homeowners paid their \$100 yearly HOA membership fee timely. Thank you so very much. However, there are a few stranglers out there. Shortly after May 1st, courtesy emails went out to home owners that had not paid. And, for those who have not provided the HOA with an email address, letters were sent. After the grace period expired certified letters were mailed. To date there are four (4) homeowners who have been re-billed due to an under payment and seven (7) who have not paid.

Currently, the HOA has 2 property liens filed for nonpayment of dues 2007, 4 property liens filed for nonpayment of dues 2008, 2 property liens filed for nonpayment of dues 2009. There is 1 property lien filed for uncorrected covenant violations. Six of the liens are assigned to two properties and the other 3 are separate properties. Several property liens have been paid in full this year. While the collection process has been difficult, slow progress is being made.

Much volunteer time is spent preparing billing notices, tracking the payments, dealing with return checks and the additional bank fees charged to the HOA for these items, sending additional billing notices, and sending certified notices to comply with the covenants. Hopefully all membership fees can be collected this year and there will be no need to file property liens.


