## Future Little Miss - 2:00 p.m. pageant

## Little Miss - 2:00 p.m. pageant

Contestants must be in 1<sup>st</sup> grade going into 2<sup>nd</sup> grade as of the 2019 NPF Pageant (Oct. 2019)

\*All contestants will compete in interview, stage presence, written communication, and on-stage question. Attire for stage presence will be Heirloom dress. Attire for interview will be outfit of choice. No opening number outfit is needed.

## Young Jr. Miss – 10:00 a.m. pageant

Contestants must be 7-9 yrs. old (7 if in 2<sup>nd</sup> grade) as of pageant date.

\*All contestants will compete in interview, stage presence, and on-stage question. Attire for stage presence will be an evening gown. Attire for interview will be Sunday dress. Opening number attire will be black pants and green shirt. No midriffs can be shown!

## Junior Miss – 10:00 a.m. pageant

Contestants must be 10-12 yrs. old as of pageant date.

\*All contestants will compete in interview, stage presence, and on-stage question. Attire for stage presence will be an evening gown. Attire for interview will be Sunday dress. Opening number attire will be black pants and green shirt. No midriffs can be shown!

## Teen Miss – 6:00 p.m. pageant

Contestants must be 13-16 yrs. old as of pageant date.

\*All contestants will compete in interview, stage presence, verbal communication, & on-stage question. Attire for stage presence will be an evening gown. Attire for interview & verbal communication will be Interview DRESS. Opening number attire will be black pants and green shirt. No midriffs shown!
