## Age Requirements and Pageant Details:

- Contestants must be currently in 1<sup>st</sup> grade, entering 2<sup>nd</sup> grade in the Fall of 2024.
- Entry fee for all divisions is \$75.00 AND at least (1) \$75.00 ad for the program.
- All contestants will turn in 1 DIGITAL copy & 1 COLOR 5 x 7 picture to be used in the program book and photogenic judging. Email the digital copy to [houstoncountypageants@gmail.com](mailto:houstoncountypageants@gmail.com) by Sunday, January 14, 2024.
- All contestants will compete in interview, stage presence, and on-stage question.
- Attire for stage presence will be Heirloom dress.
- Attire for interview will be outfit of choice.
- No opening number outfit is needed.
- Contestants in the Little Miss category are NOT allowed to wear makeup.
- Drop-off and deadline for applications, entry fee, ads, and photogenic pictures is Sunday, January 14, 2024, from 1:30-4:00 at a location to be announced.

## Pageant Rules and Regulations

- Contestants must be single natural-born females, never married, and never pregnant.
- Contestants may choose to sell more than one ad. A MINIMUM of \$75 in ads MUST be sold. Please see the Ad Agreement page for ad pricing.
- The contestant selling the most ads (monetarily) will win a \$100 cash prize.
- Ads must be turned in by January 14, 2024. Ads turned in after deadline will NOT appear in the program.
- Parental signature on application releases Houston County Pageants, Inc. from any injury or liability.
- Signature also states understanding that Houston County Pageants, Inc. will not allow Queens to compete in other pageants during their year unless given approval. Little Miss and Miss will not be allowed to enter any pageants except for the NPF pageants.
- Contestants and parents agree to recognize all decisions of judges as final.

## Reception, Practice, and Interview Information

- A “Cupcakes with Queens” reception will be held Sunday, January 21 from 2:00-3:00 at a location to be announced. This will be a fun time where we draw contestant numbers, enjoy treats, and have group pictures made for the program. The dress code is Sunday attire. We encourage participants to dress in a way that is polished and poised, while remaining relaxed and comfortable.
- Practices will be held Tuesday, January 23<sup>rd</sup> from 6:45-7:30 at a location to be announced and Friday, January 26<sup>th</sup> from 6:45-7:30 at the Dothan Civic Center.
- Interviews will be held Friday, January 26<sup>th</sup> beginning at 6:00 at the Dothan Civic Center. Exact interview times and contestant numbers will be provided at the end of the “Cupcakes with Queens” reception.
