- Attire for stage presence will be evening gown.
- Attire for interview and verbal communication will be an Interview dress, jumpsuit, or blazer and pants/skirt.
- Opening Number attire will be a green shirt, black pants, black shoes, and green or clear accessories. NO MIDRIFFS CAN BE SHOWN!!
- Drop-off and deadline for applications, entry fee, ads, and photogenic pictures is Sunday, February 2, 2025, from 1:30-4:00 at a location to be announced.

Pageant Rules and Regulations

- Contestants must be single natural-born females, never married, and never pregnant.
