Age Requirements and Pageant Details:

- Contestants must be at least 16 yrs. old and not older than 19 yrs. old as of Oct. 1, 2026.
- Entry fee for all divisions is \$95.00 AND at least (1) \$75.00 ad for the program.
- All contestants will turn in 1 DIGITAL copy & 1 COLOR 5 x 7 picture to be used in the program book and photogenic judging. Email the digital copy to houstoncountypageants@gmail.com by Sunday, February 1, 2026.
- All contestants will compete in interview, written communication, verbal communication, stage presence, and on-stage question.
- Attire for stage presence will be evening gown.
- Attire for interview and verbal communication will be an Interview dress, jumpsuit, or blazer and pants/skirt.
- Opening Number attire will be a light pink shirt, white pants, nude shoes, and light pink or clear accessories. NO MIDRIFFS CAN BE SHOWN!!
- Drop-off and deadline for applications, entry fee, ads, and photogenic pictures is Sunday, February 1, 2026, from 1:30-4:00 at Northside Methodist Academy's Fine Arts Building.

Pageant Rules and Regulations

- Contestants must be single natural-born females, never married, and never pregnant.
- Contestants may choose to sell more than one ad. A MINIMUM of \$75 in ads MUST be sold. Please see the Ad Agreement page for ad pricing.
- The contestant selling the most ads (monetarily) will win a \$100 cash prize.
- Ads must be turned in by February 1, 2026. Ads turned in after deadline will NOT appear in the program.
- Parental signature on application releases Houston County Pageants, Inc. from any injury or liability.
- Signature also states understanding that Houston County Pageants, Inc. will not allow Queens to compete in other pageants during their year unless given approval. Little Miss and Miss will not be allowed to enter any pageants except for the NPF pageants.
- Contestants and parents agree to recognize all decisions of judges as final.

- An "Ohana Luau" party will be held Sunday, February 8th from 4:00-5:00 pm at Northside Methodist Academy's Fine Arts Building. This will be a fun time where we draw contestant numbers, enjoy treats, and have group pictures made for the program. The dress code is Hawaiian themed attire. Written Communication will follow from 5:15-5:45. Contestants will be given 30 minutes to write on the topic given to them.
- Practices will be held Tuesday, February 17th from 7:00-8:00 at a location to be announced and Friday, February 20th from 6:30-7:30 at the Ashford High School auditorium.
- Interviews will be held on Saturday, February 21st beginning at approximately 10:30am at the Ashford High School auditorium. Exact interview times and contestant numbers will be provided at the end of the "Ohana Luau" party.


Whitney Dawn DeVane/Houston County Spirit of Service Scholarship
