
## MEMBER SPOTLIGHT

In 2014, I, your Historian, wrote about a member, Bert Seymour, NA 80, yes that is correct, EIGHT ZERO! Bert had contacted me to end his membership as he felt that at 90 years old he had nothing to contribute to the Association. I was the Chapter Secretary at the time and I asked Bert if I could interview him. He readily agreed and after listening to his fascinating life story and his escapades after joining the Ventura County Sheriff's Department, the first deputy hired after WWII, I decided to write about him. My article was published in the National magazine and that prompted a visit from then Captain James Fryhoff (now Police Chief) who was with the Ventura Co. sheriff's Department at the time and wanted to learn more about their history. James and another member of his department drove up to Sacramento and we had a fun afternoon looking at old photos (Bert had been one of the first CSI officers and a keen photographer).

When Bert attended the FBI Academy they were felling trees for where the academy now sits in Quantico. Bert had his class picture with J. Edgar Hoover at the helm. Apparently Mr. Hoover did not care to wait while they fidgeted around getting the picture just right, so he had a stand in while the formalities were occurring, then would take his place at the front as soon as the picture was ready to be taken. Amazingly, Bert still has all his class notes from back in the day, all nicely typed up by his lovely wife, Nancy, who accompanied him on the trip, together with their three young children and one mother-in-law! In that period, there was no housing, you were given a list of Boarding houses and you called and booked a place from the list. How things have changed!

Bert has been a loyal member ever since he graduated, I believe he must be our longest running member ever. He has spoken at our NA lunch, very funny too as he has a great sense of humor, he has attended BBQ's at members houses and we attended his wife's birthday party. Since COVID, not much has been happening and a big event passed by... Bert's 96th birthday! Not one to sit idle while the rest of the world waits for COVID to pass, Bert and his wife Nancy went about writing a book about Bert's adventures in law enforcement. The book is titled, "Cow County Lawman" (I told you he had a great sense of humor). The book is a quick read and a lot of fun, it really does give you a sense of how far we have come in law enforcement and yes, Bert mentions the NA.

Bert and Nancy are a wonderful example to us all and Bert once told me he never dreamt that fifty years on the NA would give him something to live for, but it did and now he is giving us something back. Happy reading!

Also a NA grad and a former co-worker from San Jose PD, now **Chief of Police for Gustine PD, Ruben Chavez (NA 232).** When Ruben is not working as chief of police he is volunteering his own time as a member of the San Jose Police Emerald Society Pipe and Drum Band. This is another way one of our NAA members gives back to our profession in a volunteer capacity. In addition to playing in the band, Ruben also volunteers at events and for the 2016 Monterey Conference he worked as a "bartender" in the Hospitality Suite. Ruben remains an active NAA member and hosted several divisional luncheons, one of which I attended and can be seen in a previous newsletter.



This photo of Ruben in his Pipe and Drum Band uniform was taken recently for a memorial honoring a slain SJPD officer killed in the line of duty in 1970. Ruben gave the eulogy at the memorial. The pipe band provided the traditional music for the service.

The band was formed in 2017 when they performed their first police memorial and had their fundraiser. The band obtained their 501(c)(3) and is made up of approximately 17 pipers and 8 drummers. The pipers are at different levels and the newer pipers receive instruction by other pipe instructors in the band. The band is open to all experienced pipers and drummers, especially current or retired law enforcement. The band performs at events for fallen officers and those who have died in the line of duty. The band will also provide a police presence to those retired officers who have passed away, that is in addition to performing at ceremonies, parades, police academy graduations, opening ceremonies, memorials, sporting events and fundraisers. The band averages over 25 band appearances a year.

Congratulations to recently retired Chula Vista Police Department Captain **Vern Sallee (Session #270).** Vern retired after 25 years of service to Chula Vista PD, his last 5 ½ years as a Captain. Vern is one of the country's leading law enforcement experts in the use of Drones as First Responders. He built and managed Chula Vista PD's groundbreaking Unmanned Aerial Surveillance (UAS) Team from the ground up. To date the unit has over 20 aircraft, 16 pilots, and has flown over 3,700 missions, and is considered one of the more successful and robust UAS Law Enforcement Programs in the world.

Vern has presented on Unmanned Aerial Vehicle integration at the FBINAA National Conference (2019), IACP (2019, UNC2019 (Norway) and has served as a subject matter expert with the COPS office, and as an expert on the 2020 Presidential Commission 2020 on Law Enforcement and Public Safety on the topic of public safety drones.

Vern's retirement didn't last long as he was hired by Axon as an expert for their purpose-built drone piloting application. He will be working with agencies and advising on best practices for new or existing drone operations. Vern can be reached at <u>vsallee@axon.com</u>.



## CHAPTER SECRETARY MAKES NEWS



#### CA CHAPTER SECRETARY MAKES PARLIAMENTARIAN FOR THE INTERNATIONAL ASSOCIATION OF CHIEFS OF POLICE.

Maxie C. A. Santiago is the Secretary, and Past President, for the FBI National Academy Associates, Inc., California Chapter. He previously served as the Deputy Commissioner of the California Highway Patrol (CHP) and was a distinguished member of the CHP for 30 years. He represented the CHP on the International Association of Chiefs of Police (IACP) Homeland Security Committee and Highway Safety Committee. He was formerly recognized as a Certified Inspector General by the Association of Inspectors General and a Certified Law Enforcement Auditor by the International Law Enforcement Auditors Association. He currently serves as a member of the Deadly Force Review Board for the California Department of Corrections

and Rehabilitation. Deputy Commissioner (ret.) Santiago was instrumental in creating several firsts for the CHP such as a nationally recognized computer crimes investigation unit, a joint CHP-FBI Cyber terrorism task force, a Special Weapons and Tactics Team, and was a key team member in implementing the Amber Alert system throughout California which has resulted in the safe recovery of over 337 abducted children. In 2005, he was sworn in as a Special Officer of the Louisiana State Police (LSP) during emergency operations in the New Orleans region where he oversaw 115 CHP personnel engaged in search and rescue and law enforcement operations.

Deputy Commissioner (ret.) Santiago earned a Bachelor of Science degree in Criminal Justice, Law Enforcement Management and Investigation from California State University, Sacramento. He is a graduate of the FBI National Academy, FBI Law Enforcement Executive Development Seminar, and the Law Enforcement Command College of the California Commission on Peace Officer Standards and Training.

He has been a member of the IACP since 2005 and served on the Crime Prevention Committee from 2017 to 2020 and is a member of the Private Sector Liaison Section and Retired Chiefs of Police Section. Deputy Commissioner (ret.) Santiago is a member of the IACP, Police Executive Research Forum, FBI National Academy Associates, FBI National Executive Institute Associates, FBI Law Enforcement Executive Development Association, California Association of Highway Patrolmen, and California Peace Officers Association.

Deputy Commissioner (ret.) Santiago is an author and law enforcement trainer on topics ranging from automated speed enforcement technology, emergency incident planning and operations, tactical operations, law enforcement auditing and conducting law enforcement investigations. Deputy Commissioner (ret.) Santiago proudly served our nation in the California Army National Guard and in the U.S. Army Reserve for over 21 years. He is a veteran of the Persian Gulf War and was awarded the National Defense Service Medal, Southwest Asia Service Medal, Armed Forces Reserve Medal, California Federal Service Ribbon, Liberation of Kuwait Medal (Government of Saudi Arabia), and Kuwait Liberation Medal (Government of Kuwait).
