## VERIZON/FBINAA FALLEN OFFICER FUND

## VERIZON/FBINAA FALLEN OFFICER FUND

Border Patrol Agent Alejandro Flores-Bañuelos was the first to arrive at the scene of a vehicle accident near Salton City, CA. The accident had occurred during a dust storm with low visibility. While assisting an elderly patient still in her vehicle, he was struck by another vehicle. Agent Flores-Bañuelos was transported to the Hospital where he succumbed to his injuries.

Agent Flores-Bañuelos was 35 years old, a U.S. Marine Corps veteran and had served with the United States Border Patrol for 12 years. He is survived by his expectant wife and three children.

This incident is tragic, sad and true! Unfortunately, this is not an isolated incident as sadly officers are being killed in the line of duty all too often. When tragedy strikes what is there for the family? Departments do their best to help the family, carry a share of the burden and provide comfort, but families find that there is a financial burden on top of everything else and that is hard to deal with.

A decade ago, a group of people got together, formed partnerships and the Fallen Officer Fund was started. The fund provides a measure of financial support for the survivors of any officer killed in the line of duty. It is funded and administered by Verizon/FBINAA and is managed by the public safety outreach team (PSOP) within their corporate security.

Once notice is received that an officer has fallen, the PSOP team immediately goes into action by identifying and consulting with a FBI NA graduate who is a member of the affected department or who is in the approximate area and who will quickly deliver a check to the affected survivors. It is PSOP's goal to have the check delivered within 72 hours of the officer's death notification.

Our own Chapter Secretary, Max Santiago, stated the following: "I've had the solemn privilege and honor to present a check from the Fund to survivors in my role as the Sacramento Division Vice President, Chapter President and Chapter Secretary. While it is a difficult task, it is comforting to know that due to the prompt issuance of funds from the FBINAA National Office and the timely presentation of the check by a Chapter Officer, our survivors are able to use the funds to address their immediate needs. Verizon has graciously supported this Fund for over a decade with no fan fare."

As there are still many departments who don't know about the fund, officers are skeptical when they hear from someone with news of a check for the survivors, so we need to get the word out. For those departments who have had the bad fortune to issue a check, they are always grateful and send very nice thank you letters to the PSOP team. In response to one Sheriff's thank you note, the Verizon Director of Corporate Security, Gabe Esposito said, "I received your thank-you note for our humble support of your fallen hero...Although I was very appreciative of and humbled by your kind words, we thank You and all of the law enforcement heroes who put their lives at risk every day in support of our liberties and way of life. We are truly grateful for all you do and once again express our deepest condolences. We are honored to be able to help in a small way in partnership with our friends at the FBINAA."

Support like that is comforting and uplifting and it warrants our gratitude, but this team is so humble they make it clear that they don't do it for the thanks. Their hope is the following, "We hope our support somehow helps heal some of the remaining wounds".

The Verizon/FBINAA Fallen Officer Team says it will continue to foster deep and meaningful relationships in support of their law enforcement partners whose members have made the ultimate sacrifice. WHAT A TEAM!

In 2020, 210 officers were killed in the performance of their duties, up 58 percent from 2019.

## SPOTLIGHT ON A MEMBER: BOB FRACOLLI, NA 210

Past California Chapter President Bob Fracolli spent 18 years at the San Jose District Attorney's Office after leaving Chico PD. When he retired in 2007, after 30 years in law enforcement, he and his wife Kathy purchased a beautiful home in a rural area 30 minutes outside of Chico. Bob had always been involved in volunteer work while in the Bay Area, so after moving to their rural home, Kathy signed him up for volunteer firefighting. ..Mmmmmm did Kathy do that for Bob or herself?

Bob started working with Butte County fire department and was doing 16 hours of training a month. When lightning strikes started several fires, one of which blew up, Bob and the crew responded. Below you see Bob standing behind the 3500 gallon water tender at Station 62, Harts Mill. He and a Cal Fire crew protected the station in Berry Creek while burn victims were triaged in the apparatus bay. They were surrounded by fire and no ambulances could get in or out.

When asked what he thought about being a firefighter, Bob stated, "It is satisfying, but at times hairraising...unlike law enforcement, everybody loves a firefighter and people are so happy to see you!"

Well thank you Bob and stay safe!
