Who can run?

All California Chapter members in good standing (active sworn and retired), of the San Francisco Division are eligible to run for the position of 4th Vice President - 2021. Members of the San Francisco Division must reside (if retired) or be employed by a law enforcement agency located in the Northern District of California comprised of the counties of Alameda, Contra Costa, Del Norte, Humboldt, Lake, Marin, Mendocino, Monterey, Napa, San Benito, Santa Clara, Santa Cruz, San Francisco, San Mateo, and Sonoma.

All California Chapter members in good standing (active sworn and retired), of the San Diego Division are eligible to run for the position of 4th Vice President – 2022. Members of the San Diego Division must reside (if retired) or be employed by a law enforcement agency located in the Southern District of California comprised of the counties of Imperial and San Diego.

I'm interested in running for an elected Board position, what do I need to do?

Members seeking election to the Board should notify President Craig Chew at president@fbinaacalifornia.com a minimum of 30 calendar days prior to the annual conference. Members are encouraged to notify President Chew early in the process so that they may participate in sharing their campaign message to the membership in accordance with the Campaign Protocols outlined in the Executive Board Protocol and Policies.

What positions are immediately available by appointment of the Chapter President?

All California Chapter members, in good standing, are eligible to be appointed to the Executive Board as a Division Area Representative.

<u>Area Representative</u>

All California Chapter members in good standing, are eligible to be appointed to the Executive Board as an Area Representative. There are immediate vacancies for Area Representative in the following Divisions.

- Sacramento Division Area Representative must reside (if retired) or be employed by a law enforcement agency located in the Eastern District of California comprised of the counties of Alpine, Amador, Butte, Calaveras, Colusa, El Dorado, Fresno, Glenn, Inyo, Kern, Kings, Lassen, Madera, Mariposa, Merced, Modoc, Mono, Nevada, Placer, Plumas, Sacramento, San Joaquin, Shasta, Sierra, Siskiyou, Solano, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, Yolo, and Yuba.
- San Francisco Division Area Representative must reside (if retired) or be employed by a law enforcement agency located in the Northern District of California comprised of the counties of Alameda, Contra Costa, Del Norte, Humboldt, Lake, Marin, Mendocino, Monterey, Napa, San Benito, Santa Clara, Santa Cruz, San Francisco, San Mateo, and Sonoma.
- Los Angeles Division Area Representative must reside (if retired) or be employed by a law enforcement agency located in the Central District of California comprised of the counties of Los Angeles, Orange, Riverside, Santa Barbara, San Bernardino, San Luis Obispo, and Ventura.
- San Diego Division Area Representative must reside (if retired) or be employed by a law enforcement agency located
 in the Southern District of California comprised of the counties of Imperial and San Diego.

What does an Area Representative do?

Under the guidance of their respective Division Vice President, each Area Representative assists in carrying out the business of the California Chapter. Given the geographic diversity and size of California, Area Representatives are located in strategic regions to complement the quarterly training/meetings scheduled by each respective Vice President so that participation by the membership is maximized. One of their key duties is to plan and coordinate regional luncheons, training sessions and other activities for the members of his/her Division as directed by their respective Vice President.

I'm interested, how can I find out more about the appointment process?

Candidates for Area Representative must be nominated by their respective Division Vice President and appointed by the Chapter President. At least one Area Representative from each Division shall be nominated and appointed for a one-year term. Contact your Division Vice President to learn more:

We are sad to report the passing of:

John "Jack" Kearns





One of Sacramento's finest, retired Chief **Jack Kearns, NA 83**, passed peacefully in June. Jack joined the Sacramento Police Department in 1956 upon discharge from the Marine Corps where he had served during the Korean war, following his father, Patrick. He had many family members in law enforcement; two aunts who were the first female matrons in Sacramento PD in the early 1900's, an uncle, Jim who was a warden at Folsom Prison and another uncle in NYPD.


During his years as a patrolman and detective, he attended night school and graduated from CSUS with a B.A. and M.A. degree in Law Enforcement and Public Administration. Other professional certificates were achieved from different FBI programs, U.S. Dept. of Justice, and many more. He served his community for 36 years and as the "Tough but Compassionate" Chief of Police from 1977 to 1992.

Under his fifteen-year leadership as Chief, he instigated a long list of legislation, like AB497 with legislator Lloyd Connelly to require a 15-day waiting period for gun purchases.

He was a strong supporter of the Police Athletic League, he himself was an avid boxing fan and a boxing champ in the Marine Corps. The youth center at 3520 5th Avenue was built in 1985 and named the John P. Kearns Youth Center. At 52 years old he ran the 5-mile Crime Alert Run against many law enforcement agencies across the state. His favorite activities were the infamous PIG BOWL, especially when the Sacramento PD Cops beat the Sheriff's Dept.

He was very proud to be Sacramento's Irishman of the Year and Grand Marshal of the St. Patrick's Day Parade, because he was a very proud true Irishman!

The City of Sacramento Public Safety Center, dedicated to Chiefs Deise (Fire) & Kearns (Police) on Freeport Blvd. was named after Chief Jack Kearns.
