
***Elections for the Vice President positions for both the San Francisco and San Diego Divisions will be held at the California Chapter Annual Retainer in October 2021.

Youth Leadership Program Update:

As we all can attest, nothing this past year has not been affected by the pandemic. The Youth Leadership Program (YLP) is certainly no different. The YLP continues to be an excellent program for our youth, not only those interested in a career in law-enforcement, but those looking to develop themselves holistically and prepare for higher education and advancement in life.

Because of the unique challenges that we faced this year and the 2020 YLP being canceled, The board voted unanimously in October to send the two candidates selected from Southern California to the 2021 YLP (if it occurs). Because of this, and to keep the rotation between northern and Southern California on the same rotation, there will not be an application process until November of 2021. Only students from Southern CA will be eligible to apply for the 2022 YLP. Students in Northern CA, will be eligible to apply for the 2023 session in November of 2022.

Assignments during his tenure with the SJPD included Vice, Narcotics / Covert Investigations, the San Jose Airport, Police Personnel, and the Northern California Regional Intelligence Center (NCRIC). In addition to attending the FBINA while with the Police Department, he served as an Executive Fellow at FBI Headquarters in Washington DC when assigned to the National Joint Terrorism Task Force, post 9/11.

Scott left the San Jose Police Department when hired as the Assistant Chief Investigator with the Santa Clara County District Attorney's Office. While acting in this capacity he continued his involvement with the FBINAA, hosted training, and was successful in reintroducing that agency to the National Academy. This agency continues to realize the value of the FBINA and continues to send personnel. He retired from this agency after another 6 years of service, bringing total sworn law enforcement experience to over 32 years in sum.

In addition to graduating from the NA, he has a Bachelor's Degree in Criminal Justice from San Jose State University, a Master's Degree in Leadership from St. Mary's College, and is a graduate of the California POST Command College. He looks forward to the opportunity to bring added value to FBI National Academy Associates' members at all levels of their careers.

Happy New Year to our Section 1 leadership. I hope you are all well and easing into the new year. As you are all aware, 2021 continues to be a challenging time for all of law enforcement and for the FBINAA as well. I wanted to provide some updates and solicit some feedback on the below topics:

- 1. The FBINAA Training Committee, chaired by Section 4 Representative Bill Carbone, is looking for a Section 1 representative to the committee to replace Commander Jody Makuch (245th) who tragically lost his life in a motorcycle accident on September 7th, 2020. If you have someone who is interested or who you would recommend please send me their names, session # and a positive recommendation in a short email by **January 22, 2021.** The identified person should be an active member of your Chapter, have a strong training background and able to commit to regular Committee meetings.
- 2. National Academy sessions continue to be rescheduled due to COVID concerns. A virtual session is being discussed and may be offered as a viable option; there is not timeline on the return to a more traditional, on campus session.
- 3. Membership renewals for 2021 are now open and should have been emailed to all of our membership. Additionally, membership renewal can be done via the FBINAA App. Membership is the center of our great Association and our Section has done a great job of membership retention. Keep up the great work!
- 4. YLP2021 will no longer be offered on NA property due to COVID concerns. Executive Director Howard Cook and National Office staff are exploring other options and will provide updates as soon as they have any.
- 5. The ED and FBINAA Executive Board are exploring options for a potential Chapter Leadership Summit in 2021. Options under consideration include Las Vegas, Orlando and potentially Connecticut; no firm dates have been identified. As I learn more I will share it as soon as possible.
