# Member Spotlight **Garrett Zimmon, NA 134**

I, **Garrett Zimmon**, recently attended the Past-Presidents Dinner at the California Chapter Conference in Long Beach, CA. Of the nine past presidents in attendance, I was the most senior, both in terms of NA Session and as Chapter President. At the event I met Historian Gina Di Napoli, who asked if I would write an overview of my career and the impact the NA had on my career, so here I go.

I began my law enforcement career with LAPD in 1973. I had heard of the National Academy and hoped to one day be selected. In 1982, I was promoted to Lt and was selected to attend the 134<sup>th</sup> session (July10 to September 23,1983 -11 weeks). The FBI Academy was less formal than today and the Jefferson Dorm did not exist. Entry into the Academy was the small square building at the top of the horse-shoe driveway (to the left of today's Jefferson wing). The dress was just collared shirt and slacks. We started with 250 class members but graduated with less due to family/work emergencies. To this day I remain in contact with many classmates, one in particular, from a police department in Maine, flew out and brought lobsters for my promotion party when I made Captain. I have never regretted choosing to stay involved with NAA. I have attended quarterly events, Conferences and when possible, the National conferences. I also coordinated several quarterly training sessions, arranging speakers such as the Chief Justice of the California Supreme Court and Roy Rogers, remember him?

One of my career highlights was being part of the planning committee for the 1991 National FBINAA Conference in San Diego. It was held at the Hotel Coronado on Coronado Island. It was at that conference I was elected to 4<sup>th</sup> vice-president of the California Board. I served as the California Chapter President in 1995.

How as the FBINA impacted my career? That was an interesting question. I guess it started with my attendance at Session 134. While the course work was valuable, the greatest take-away was the exposure to my 250 classmates, it opened the door to networking with so many law enforcement professionals. There has never been a time, when reaching out to a NA graduate, that they did not go out of their way to help. I have returned the favor for many NA members who reached out to me.

I am sure it was because I stayed so active with FBINAA that in 1991, I was one of four NA grads who were chosen to teach a middle manager course for the Ministry of Internal Affairs (MVD) at the Police Academy in Moscow, in February and boy was it cold!!! That was quite an experience and opened the door to a future career in international training. Later in 1999, I participated with 3 FBI agents in presenting a joint Jordan/Israeli Senior Management course in Israel. As far as I knew, that was the first high level joint training with the two countries. I met an Israeli NA grad who made us feel at home and assisted with understanding the cultures of the two countries, something which holds much relevance today. Another NA graduate from Maryland, who I met at an IACP event, went to work for the International Criminal Investigative Training Assistance Program (ICITAP) at the US Department of Justice. He reached out and asked if I could make a presentation at an international training session in Bangkok, Thailand. Bangkok has one of the four US State Department International Training Academies in the world. Yet another international experience! In 2002 I retired from the LAPD and took a position as Chief of Police in San Bernardino, CA. San Bernardino had not sent anyone to the NA for many years, so I was instrumental in getting San Bernardino back on the eligibility list and since then has had several NA attendees. After retiring from San Bernardino PD, I went to work as Assistant Director at ICITAP and oversaw training and assistance programs in Europe, Eurasia, Mexico, Central and South America and the Caribbean. We had teams that conducted assessments of the status of police and investigative agencies and worked with the State Department to fund assistance programs. As you can imagine, there are things agencies say they need versus what they really need, to confirm, I always looked up NA grads from those countries and sought their insight, as they tended to be more accurate and cooperative.

I have had a wonderful law enforcement career. I am proud to be a National Academy graduate, and my NA experiences truly made a difference in my career and my life. That is one of the reasons I have remained active and am now a Life Member of the FBINAA. While this is my story, there is no doubt in my mind that each graduate has experiences that would not have been possible without the FBINAA.

He went on to explain how the legislature has been changing the laws on a nearly annual basis and that, under the law, diversion is not appropriate for super strike offenses. Judge Manley's presentation was incredibly informative and well received.

Additionally, it was a pleasure to host our **Chapter Historian, Gina Di Napoli**, who made the long drive to attend this event, as well as two local command officers who are on the list to attend future NA sessions. We always welcome agencies to send interested candidates to our events to engage with our members and FBI staff.
