VETTING

 - ☐ REQUIRED BY RESCUE: DHPP / RABIES / MICROCHIP / ALTER
 - ☐ IF THERE IS NO PROOF OF THESE RECORDS, THEY NEED THEM AGAIN
- ☐ PROVIDED BY THE RESCUE:
 - ☐ OLDER THAN 8 MONTHS: HW TEST
 - ☐ AT LEAST 8 WEEKS OF AGE, BORDETELLA (KENNEL COUGH VACCINE)
 - ☐ OLDER THAN 16 WEEKS, THEY REQUIRE 2 DHPP SHOTS 3-4 WEEKS APART
 - ☐ DHPP #1 Date given _____

- ☐ YOUNGER THAN 16 WEEKS, THEY REQUIRE 3 DHPP SHOTS 3-4 WEEKS APART

PRE-ADOPTION

- ☐ ALL PETS *REQUIRE* AN ADOPTION APPLICATION ON FILE
- ☐ CHECK AGAINST DO NOT ADOPT LIST (SEE CANINE COLLECTIVE)
- ☐ HAVE YOU HAD A MEET AND GREET?
- ☐ HAVE YOU COMPLETED VET REFERENCE
- ☐ **REQUIRED:** TO MEET ALL RESIDENTS OF THE HOME
- ☐ HOME VISIT CHECKLIST
- ☐ COPY OF ALL VETTING RECORDS

- ☐ VETTING STATUS OF DOG
 - ☐ DOES IT REQUIRE MORE SHOTS (DHPP / RABIES)
 - ☐ DOES IT REQUIRE A MICROCHIP
 - ☐ SCAN FOR CHIP AND RECORD NUMBER
 - ☐ DOES IT HAVE AN APPOINTMENT DATE
 - ☐ FOSTERING MINIMUM:
 - ☐ TWO WEEK HEALTH HOLD
 - ☐ IF A PUPPY IS UNDER 10 WEEKS, THERE IS A MINIMUM OF A THREE WEEK HOLD TO ENSURE IT IS PROTECTED ENOUGH TO BE ADOPTED OUT BUT **NO PUPPY** WILL BE ADOPTED OUT BEFORE THEY ARE 8 WEEKS OF AGE.

YOU **MUST** OBTAIN COPIES OF ALL RECORDS INCLUDING THE MICROCHIP NUMBER AND PROVIDE TO ADMINS (THIS MEANS IF A DOG WAS ADOPTED THAT REQUIRES MORE VETTING YOU WILL FOLLOW UP WITH ADOPTERS TO GET THE COMPLETED RECORDS) THIS INCLUDES UPDATING YOUR FOSTER'S GROUP CHAT WITH THE DATE OF ANY RECEIVED REQUIRED SHOTS AFTER ADOPTION★★
