ARTICLES OF INCORPORATION

OF

HORSESHOE CLUB, INC.

I.

The name of the corporation is: HORSESHOE CLUB, INC.

II.

The corporation is organized pursuant to the provisions of the Georgia Non-Profit Corporation Code.

III.

The corporation shall have perpetual duration.

IV.

The corporation is organized for the following purposes:

To own, manage, control and maintain certain lands in Camden County, Georgia, in or adjacent to Horseshoe Cove Subdivision of Camden County, which lands shall be common use areas for subdivision lot owners who shall pay an annual assessment to the corporation for the privilege of use of the areas owned by the corporation; to make improvements to any of its properties; to do all things necessary and incidental, expedient, ancillary or in aid to the accomplishment of the foregoing, including when necessary, the buying, selling, leasing or mortgaging of real or personal property; and to do all legal acts incidental to carry on the general purposes of said corporation.

The affairs of the corporation shall be managed by a Board of Directors which shall consist of five (5) persons, all of whom must maintain membership in the corporation during their term. The directors shall be elected by a majority vote of the membership present and voting at the annual membership meeting and shall hold office for a period of two (2) years after the initial terms. Three (3) of the directors shall initially be elected for a period of two (2) years and two (2) of the directors shall be elected for an initial term of one (1) year.

VI.

The corporation shall have one class of members with two clases of voting members. All owners of lot or lots in Horseshoe Cove Subdivision of Camden County, Georgia, shall be members of the corporation. Each lot shall represent one membership. On any issue which is before the membership for a vote each membership of a lot which adjoins the water shall have two votes, and each membership of a lot off the water shall have one vote. A majority vote of the membership present and voting on any issue will govern the actions of the corporation.

VII.

The corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property of the

corporation and no part of its revenues shall inure to the benefit of any director or other private individual. However, the corporation may engage or employ any of its directors or members to perform services for the corporation that are a part of its general purposes. The corporation shall never be authorized to engage in a regular business of a kind ordinarily carried on for profit or any other activity except in the furtherance of the purposes stated above for which the corporation is organized.

VIII.

The initial registered office of the corporation shall be located at Route #1, Horseshoe Court West, Waverly, Georgia 31565. The initial registered agent of the corporation shall be Seaborn W. Bell, and his written consent to such appointment is attached to these Articles of Incorporation.

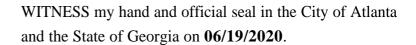
