

ACCOMMODATION TERMS, INDEMNITY & DISCLAIMER

(Applicable to all guests making use of Waterberg Breezers Accommodation and/or entering Farm Houtboschrivier K307, Mookgophong, Limpopo, 0560)

By confirming a booking, making payment, or entering and occupying the accommodation premises, guests acknowledge that they have read, understood, and agreed to the following Terms, Indemnity and Disclaimer. These terms apply automatically and without the need for signature.

1. ASSUMPTION OF RISK

Guests understand that the accommodation is located on a working farm or rural property, where natural and agricultural hazards may be present, including uneven ground, open water, livestock, electric fences, machinery, insects, and wildlife. By choosing to stay on the property, guests voluntarily accept all risks associated with such an environment.

2. LIMITATION OF LIABILITY

Neither the owners, their employees, agents, nor representatives (collectively referred to as “the Owners”) shall be held liable for any loss, injury, illness, damage, death, or expense of any nature whatsoever that may occur to any guest, visitor, or their property, whether arising from negligence or otherwise. Guests hereby indemnify and hold the Owners harmless against all such claims, including those arising from the acts or omissions of other guests, service providers, or third parties.

3. PERSONAL BELONGINGS

All personal items, including vehicles, valuables, and equipment, are brought onto the premises entirely at the guest’s own risk. The Owners accept no responsibility for loss, theft, or damage, however caused.

4. CHILDREN AND DEPENDANTS

Children and dependants remain the sole responsibility of their parents or guardians at all times. Parents must ensure proper supervision and safety, particularly near animals, water sources, and farm equipment.

5. DAMAGE TO PROPERTY

Guests are required to treat the property and all contents with care. Any breakages or damages caused, whether accidental or intentional, must be reported and will be charged to the guest responsible.

6. SAFETY AND CONDUCT

Guests agree to abide by all safety rules and reasonable instructions displayed on the premises or provided by the Owners. No entry is permitted into restricted, fenced, or private areas. Open fires are allowed only in designated braai areas and must be properly extinguished after use.

7. MEDICAL CARE AND EMERGENCIES

Guests are responsible for their own medical needs. In the event of illness, accident, or emergency, any assistance arranged by the Owners is done so in good faith and at the guest's own expense and risk.

8. FORCE MAJEURE

The Owners shall not be liable for any loss, inconvenience, or change in circumstances caused by events beyond their control, including but not limited to power outages, water interruptions, fire, weather conditions, or acts of nature.

9. ACCEPTANCE OF TERMS

By paying the booking deposit, confirming a reservation, or entering the premises, guests automatically accept and agree to be bound by this Indemnity and Disclaimer. This agreement remains in effect for the duration of the guest's stay and applies equally to all members of their party and visitors.
