#### 1. Information We Collect

When you opt-in to our text messaging services, we may collect the following information:

- **Personal Information:** Name, phone number, and other contact details.
- **Health Information:** Health-related information you choose to provide in your text messages, such as appointment scheduling, reminders, and health updates.
- **Usage Data:** Information about how you interact with our text messaging service, including delivery and read receipts, response times, and message history.

### 2. How We Use Your Information

- Service Providers: Trusted third-party vendors who assist us with delivering text messaging services (such as SMS providers), but they are bound by confidentiality agreements to protect your information.
- Legal Authorities: If required by law, such as in response to a subpoena or other legal request.
