3. Walking in rugged country, including encounters with wildlife, animals, and insects.
4. Inclement weather conditions.
5. The risk of injury from riding on all terrain vehicles(ATV) or any vehicle used off the paved road.
6. The risk of injury from the use of hunting blinds; A-Frames and layout blinds.

I understand the risk, hazards, and dangers of hunting and have had the opportunity to discuss them with FOWL AFFLICTION OUTDOORS, LLC . I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities.
