## **ENTRY INFORMATION**

### **YOU CAN ENTER THE TRIAL VIA AKC'S ONLINE ENTRY SERVICE**

Go to the AKC Agility Online Entry Services home page at [www.akc.org/AgilityEntry](http://www.akc.org/AgilityEntry) and follow the instructions there to use your 'My AKC' account to enter this event online. (Please note that AKC charges a small processing fee for online entries.) During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: Online: 100 runs on Sat/Sun/Mon and 600 Paper runs on Sat/Sun/Mon. If either form of entry (paper or online) has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

**\*\*\*Hand deliveries cannot be accepted during the first 24 hours after the trial's opening.\*\*\***

- Limit: 10 entries per envelope. One entry = one dog. Envelopes containing more than 10 entries will be returned.
- Paper entries received within 24 hours of the opening date & time must: 1) include postage or be metered; 2) be delivered by a multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to sender. You must waive signature requirements when using services that utilize signature verifications.
- Owners are responsible for ensuring that entry forms are completed in full. Entries submitted without ALL information will be returned as invalid.
- All entries must be submitted on official AKC agility entry forms, one dog per entry form. Photocopies of entry form will be accepted only if legible [and official AKC size](#).
- Entries will not be accepted without signature, fees and reverse side of entry form with agreement signed, nor will credit cards or faxed entries be accepted with paper entries.
- Returned checks do not constitute a valid entry; no refund for duplicate entries. Returned checks do not constitute a valid entry fee. There will be a \$25 service charge for returned checks.

### **JUMP HEIGHT CARD PROCESS**

**A COPY OF THE DOG'S JUMP HEIGHT CARD IS NO LONGER REQUIRED TO BE SUBMITTED WITH YOUR ENTRY.**

**However, exhibitors are required to have the official form/card with them at the trial to present upon request.**

The entry form has a section at the top of the form for exhibitors to designate if the dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record who is not a VMO (measuring official), that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

#### **Ring SETUP**

Unloading the trailer and setting up the ring will begin at 1:00pm on Friday Nov 8th.

The first 10 people to notify Carol Lukes ([weims3@verizon.net](mailto:weims3@verizon.net)) about helping with setup from 1:00 pm until complete, will receive a certificate for a future DTCT trial for **1 dog, 1 day, max 3 runs. (a \$47 value).**

If you can help, but can't be there at 1:00 pm or are unable to stay until finished, you will earn a \$4.00 Worker card per hour for a future entry or it can be used at the food vendor.

#### **Working During the Trial**

#### **Reduced entry fee for Worker online sign up (before mailed entry is received):**

Instead of an extra \$2.00 worker ticket for the day(s) you sign up (online) to work before the trial, **we are offering a \$5.00 reduced entry fee for each day you signup before your mailed entry is received and processed by the trial secretary.** The \$5.00 is in addition to the \$2.00 worker ticket you will receive for working each class or jump height during the trial. **(This is available only to non DTCT club members. Reduced \$5.00 entry fee needs to be included with your original entry sent to the trial secretary. The \$5.00 entry reduction is not available after the paper entry is received.)**

#### **Online Entries through AKC**

If you enter the trial online through AKC's website and complete the DTCT's online Worker sign up before closing, Oct. 25, we will give you \$5.00 for each day you signed up to work online. (Please notify the trial secretary or volunteer contact, Cindy

**EXHIBITOR INFORMATION**

- Dogs may be brought to start line on slip leads, choke chains, head halters, body harnesses or other collars that are permitted on the trial grounds. Pinch/prong and electrical (dummy or not), and special training collars are not allowed on the trial grounds.
- PLEASE PICK UP AFTER YOUR DOG!
- Running order will be determined by computer-generated random draw. Handlers with multiple dogs in one class will have those dogs separated as much as possible.
- All dogs present must be on leash or confined in crates when not being judged or at the warm up jump.
- Free parking is available for exhibitors. Park at your own risk.
- Exhibitors may wear shirts or insignia of their training group.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.
- The Club and the Trial Secretary have no obligation or responsibility to provide a public address system or stewards to call or locate dogs that are not present at the ring when required. Exhibitors are responsible for being at the gate when it is their turn to run.
- The Club and the Trial Facility will not be responsible for the loss of or damage to any dog exhibited, or for possessions of any exhibitor, whether the result of an accident or any other cause and further assume no responsibility for injury to children. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that every dog at this trial is in the care and custody of his owner or handler during the entire time the dog is in the trial building or on the grounds. However, the Event Committee reserves the right to enter or authorize entrance to a vehicle using whatever means necessary to rescue dogs in distress. All persons attending this trial hereby waive any claim for damages against the club for such removal.
- Exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. No refund of entry fees will be made.
- Dogs may not be left overnight at the trial site

**DIRECTIONS TO THE TRIAL SITE**

**Directions from I-75** - Exit 224 (old 43) onto US 301 Westbound. It becomes 10th St. West in Palmetto. Continue to 14th Avenue. Turn right on 14th and continue to the Fairground Entrance.

**Directions from Pinellas County** - I-275 south over the Skyway Bridge (\$1.25 Toll). Take the first exit (US 19 - Exit 5, old exit 2) south. Where US 19 splits into US41/Business 41, take the Business 41 branch to the right. Turn right onto 17<sup>th</sup> St. in Palmetto, then left onto 14th Ave. and continue to the Fairgrounds entrance.

**HEIGHT DIVISIONS**

**Owners, exhibitors, and/or handlers are responsible for entering their dogs in the proper height division.** Exhibitors may choose to enter their dogs in a higher height division than required by AKC, but not in a height division lower than the AKC mandated height. Dogs in the Preferred Classes **MUST** jump in their preferred measured height division.. They may not enter in a higher jump class.

## WALK-THRUS & WARM-UPS

Handlers are permitted to walk the course, without a dog, prior to the start of the class. walk-through is restricted to handlers entered in that class/jump height.

## RING DIMENSIONS & SURFACE

The trial will be held outdoors, under cover on a dirt surface. This set of trials uses electronic timers. The ring sizes are a minimum of: **110' X 100**.

## REFUND POLICY

- Entry fees will be refunded if an entry is pulled before the closing date and time.
- The club will provide full refunds less \$8 per day processing fee for bitches in season. Verification in writing must be submitted to the Trial Secretary no later than 30 minutes before the start of the trials. Refunds will be mailed after the trial.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by judge, barred from competition by action of the Event Committee, or is ineligible to compete due to being entered incorrectly or if a trial cannot open or be completed.
- Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

### MOVE UPS

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Monday preceding the event. (See the move-up deadline date on the cover of this premium). Day-to-day move ups are allowed provided the Trial Secretary is notified at the show site, in writing within 30 minutes of the last dog completing the course. Forms will be available at the show site. Please email pre-trial move-up requests to the Trial Secretary at [weims3@verizon.net](mailto:weims3@verizon.net) on or before the deadline noted on the cover of this Premium. No form is necessary, but please include the following information:

- Your first and last name
- Your dog's call name
- The class and jump height to which you would like your dog moved

## ENTRY CONFIRMATIONS & JUDGING PROGRAMS

OWNERS/HANDLERS ARE RESPONSIBLE FOR REVIEWING ALL INFORMATION IN THE CONFIRMATION LETTER EACH TIME IT IS SENT AND CONTACTING THE TRIAL SECRETARY IMMEDIATELY IN WRITING (EMAIL) IF A CORRECTION/CHANGE NEEDS TO BE MADE. CORRECT AKC REGISTRATION # OR ILP # IS CRUCIAL.

NOTE: If you have a spam filter in place on your email account, please add the trial secretary's email address to your accepted address list. If you are not receiving emails from the trial secretary, it is your responsibility to notify the trial secretary to reach a resolution.

**Any exhibitor who does not receive a preliminary confirmation within 10 days of mailing a paper entry should contact the Trial Secretary to confirm receipt of paper entry.**

Any exhibitor who does not receive the Judging Program within five (5) days prior to the trial, should contact the Trial Secretary. Always bring a paper copy of your confirmation letter to the trial. Corrections to the confirmation letter that are not brought to the trial secretary's attention at the time of receipt will render the database as the final authority for the day's information.

## CLASSES & TITLES OFFERED

Classes offered at this trial are listed on the front of this premium. Please see the AKC Regulations for Agility Trials for current class descriptions. Dogs must be entered only in Regular Classes or Preferred Classes with no cross-over between classes allowed at the same set of trials.

## AWARDS

Ribbons will be awarded to the 1st through 4th place dogs in each Standard and JWW class, and 1st place in each T2B jump height per AKC rules. Qualifying ribbons will be awarded to dogs receiving qualifying score. Dogs must qualify to receive a placement ribbon. New Title rosettes will be available for new titles earned at this trial. Special MACH, PACH ribbons along with a MACH/PACH pole will be available for dogs earning those titles at this trial. PAX Ribbons will be available for dogs earning a PAX title.

## ELIGIBILITY

All dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Wherever the word "dog" is used in these regulations, it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

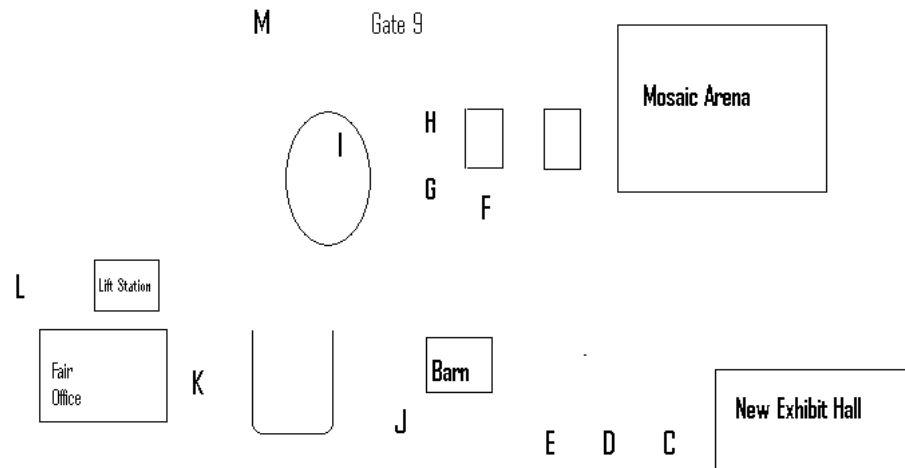

If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
