**\*\*\* APPLICATION MUST BE SUBMITTED TO THE ASSOCIATION NOT LESS THAN 30 DAYS BEFORE THE MOVE-IN DATE OR CLOSING DATE. APPLICATIONS WILL NOT BE PROCESSED IF ANY DOCUMENTS OR PAYMENTS ARE MISSING AND COULD RESULT IN DELAYS \*\*\***

### **PROPERTY REQUIREMENTS:**

Local Palm Beach Co. Sheriff's Report - Please visit <https://www.pbso.org> or phone (561) 688-3000 and request a "Name Only search of arrest and jail booking records compiled by the Palm Beach Co Sheriff's Office." **Each** applicant over the age of 18 **MUST** obtain a Criminal History Report from the Palm Beach County Sheriff's Office and submit it along with this screening application package. Palm Beach County Sheriff's Office (561) 688-3000 or <https://www.pbso.org>.

### **PURCHASE and LEASE:**

- Credit score must be 620 for at least one applicant
- No More than two (2) occupants per room
- Each applicant over the age of 18 must submit **an individual application** unless married. If married, a marriage certificate **must** be provided to tenant evaluation.
- A **non-refundable** \$100 processing fee(s) made payable to **Charleston Commons** by cashier's check or money order should be made to our office at **7000 Atlantic Ave, Suite 200, Delray Beach, FL 33446**, or leave it in our drop box at the address previously listed. **Married couples require ONE processing fee. Unmarried individuals require separate processing fees. These costs are separate from tenant evaluation application fees.**
- Rush fees may be paid via Tenant Evaluation. (This does **NOT** guarantee faster action by the board.)
- Transponders **MUST be paid for by cashier's check or money order**, made payable to **Charleston Commons**. \$50 per transponder mailed to our office at **7000 Atlantic Ave Suite 200, Delray Beach FL 33446**, or leave it in the drop box at the address listed above. Transponders are to be picked up in person and **cannot be mailed**.
  - **Villas are allowed 2 vehicles/transponders.**
  - **Townhomes are allowed 3 vehicles/transponders (townhomes have garages)**

All documents requested by tenant evaluation **are required** by the association for consideration of approval. The application will **not** be processed if any documents are missing. This includes (but is not limited to) the following:

- Driver's license, vehicle registration, vehicle insurance, the signed lease/purchase agreement, marriage certificate (if applicable), pet information (if applicable).

### **PET RESTRICTIONS:**

- Maximum one (1) pet per Rental Agreement and cannot exceed 25 lbs.
- Charleston Commons reserves the right to deny any pet at any time for any reason both prior to a lease or during a lease should the pet become a nuisance.
- A picture of the pet, weight, and any documentation if available must be provided.
- Some restricted dog breeds:
  - Pitbull, Pitbull Terrier, Staffordshire Terrier, Rottweiler, German Shepards, Tosa, Presa Canarios, Chow Chow, Doberman Pinschers, Doberman, Akitas, Wolf-Hybrids, Mastiffs, Cane Corsos, Great Danes, Alaskan Malamutes and Siberian Huskies.

### **LEASE ONLY:**

- Security Deposit of **ONE FULL MONTH'S RENT** required, made payable to **Charleston Commons Community by MONEY ORDER ONLY.**
- A copy of the rental tax certificate (provided by the landlord) along with your signed lease agreement must be uploaded to tenant evaluation.

**Should a potential occupant move in without prior written approval, the Association will impose a \$100 fine per day up to one thousand dollars maximum in your account without any further notice. Occupancy to be approved by the Homeowners Association.**

**\*Lease is subject to renewal at the end of the lease term\***

**Please note: Prospective buyers and/or tenants will NOT be approved if the sellers and/or landlords are delinquent on their maintenance account and/or if they have any pending violations.**
