At this wonderful and friendly gathering we were presented with two great topics of discussion. The first was The Gatton Essay Contest Winner -Logan Mintz's presentation of her winning essay and the second was the by the keynote speaker North Carolina Society Historian Stewart E. Dunaway. Ms. Mintz provided us with a glimpse into North Carolina's colonial past through a very scholarly essay concerning Wilmington's role during the War for Independence.

. In addition, on hand to hear the presentation was Mrs. Gatton. We were very pleased to have them both on hand for a memorable summer gathering. In addition, Compatriot Dunaway's presentation focused upon a discussion of his book the "Civil War in the American Revolution". Of course, that left the victors the greater question of how to repair the very structure of society that had been divided by a contentious war.

## **By-Laws and Constitution Changes**

#### Change to By-Laws:

Article III - Duties of the Officers

The President, with assistance from his committees and the Board of Managers, shall: establish and announce the annual schedule of events for the Chapter, preside at meetings, and represent the Chapter at the State Board of Manager Meetings. The President shall be in charge of contracting all services required for the annual schedule of events. The President can delegate the responsibility, but is ultimately responsible. The Vice President shall perform these duties in the absence or incapacity of the President.

The Secretary shall: maintain the list of members, prepare correspondence to inform the membership of Chapter activities, maintain the minutes of the meeting, see that the meeting and activities correspond to the Constitution of the Chapter and the Chapter Bylaws.

The Treasurer shall: collect dues, collect dinner reservation payment, pay all approved obligations of the Chapter, keep the financial records and provide the Treasurer's Report at each meeting. The Treasurer may confer with the President and obtain authorization to make changes in banking or financial arrangement prior to a meeting. Member approval will be obtained at the next scheduled Chapter meeting.

The Historian shall: maintain a record of the chapter and its membership over time.

The Genealogist/Registrar shall: provide guidance on filing applications, review applications for completeness before forwarding them to the State Society, and inform the Secretary-Treasurer of the names and addresses of approved members.

#### **Change to Constitution:**

Article IV - Officers and the Board of Managers

The officers of this Chapter shall be the: President, Vice President, Secretary, Treasurer, Historian, Chaplain, and Genealogist/Registrar. Said officers shall constitute the Board of Managers and they shall each serve a term of two years or until their successors are qualified. Their duties shall be those customarily performed by such officers plus any duties specified in the By-Laws of this organization.

Vacancies among the officers are to be filled by appointment by the President, or, in his absence, by the Board of Managers until the next regular meeting of the Chapter.

ELECTION: Nominations for officers of the chapter may be made by a nominating committee of three appointed by the President. Nominations may also be made from the floor at the time of the election. Officers shall be elected every second year at a meeting of the general membership and shall be determined by the majority vote of the active members in attendance. The Historian is an appointed position by the President and requires no vote of the membership.



# Alderman Honored as Patriot—From the "Sampson Independent"

DELWAY — As family members who are descendants of Daniel and Abigail Harris Alderman gathered to meet and enjoy fellowship together on June 26, they paused to pay tribute to John Alderman Sr. With relatives beginning to gather at Hinson Hall at Evergreen Baptist Church in Delway, many departed to travel to the Alderman Cemetery about three miles from the church on Powell Page Road.

The grave-marking ceremony took place last weekend, with many direct descendants of John Alderman Sr., who fought in the American Revolution, in attendance. Back in the late 1960s, the National Society of the Daughters of the American Revolution (DAR), marked his gravestone to honor his service in the war. Last weekend's ceremony was held by the N.C. Society Sons of the American Revolution (SAR). The Alderman Historical Association, represented by president H. Sidney Bland III, who is a direct descendant of Alderman, was on hand to welcome the crowd gathered as the SAR color guard presented the colors. After placing flags behind the gravesite, they marched back to stand at attention for most of the remaining ceremony.

As a common practice of grave-marking, a wreath was laid by other groups taking part in the ceremony. Mike Mathis, another Alderman descendent, and Hugh Williams presented the first wreath.

Pansy Alderman Elliot, a direct ancestor of Alderman Sr., laid a wreath by the Colonial Dames XVII Century. The Colonial Dames is an organization that can prove their direct lineage to an ancestor that lived and served the colonies prior to 1701. Susan Corliss-Bland laid the DAR wreath presented by the Edenton Tea Party Chapter. Honors were also paid by the John Ashe Chapter of CAR with Christa Bland, Rachel Bland (both direct descendants) and Cline each laid a single rose on the grave. It was the first time a CAR chapter in North Carolina participated in a grave marking service.

Bland stated that "although many people living today probably had ancestors who have been here in the country over 200 years, it is a special thrill to actually know the names and dates and personal stories of the people you came from."

He went on to share that in 1965 John Alderman secured from Governor Tryon a grant for 300 acres of land on

Doctor's Creek in Duplin County. Over his lifetime he continued to buy more land as he could, eventually ending with an estate of 700 acres.

One touching memoir read of Alderman Sr. was that he loved to read and frequently read from his Bible in the afternoon, sitting in the shade of a large tree in his yard. At the age of 85 he was found sitting in his chair with his Bible in his hand, dead.

"What a wonderful ending to a life lived with honor and valor," concluded Bland.

Two new tables have been loaded to our SAR Raleigh Chapter section of the SAR State Web Site containing all known members of the Raleigh Chapter, Sons of the American Revolution. It was compiled from state and chapter rosters and yearbooks from 1968 to 2010, National Society records of deaths and dropped members, the published SAR Membership roster of 1997 and other records held by the chapter. For privacy reasons, the Web site contains only the National Society SAR#, current

membership status, name dates the member was active and the last city and state of residence are displayed. A second file is also loaded which has a list of the Patriot Ancestors and the Raleigh Chapter members who are descended from them. Both of these files can assist with genealogical research and prospective membership.
