- 1. Participation: By participating in the bike ride event "Cycle for Chanelle", you agree to the following terms and conditions.
- 2. Acknowledgement of Risk: You acknowledge that cycling, especially on public roads, carries inherent risks and may result in serious injury or death. You are fully aware of the risks and dangers associated with cycling and voluntarily assume all risks associated with participating in the Event.
- 3. Safety Equipment: You agree to wear appropriate safety equipment, including a helmet and any other safety gear recommended by the Event organizers, at all times during the Event. You understand that failure to do so may increase the risk of injury or death.
- 4. Compliance with Laws and Instructions: You agree to obey all traffic laws and regulations, as well as any instructions or directions provided by the Event organizers or marshals. You agree to ride in a safe and responsible manner, and to not engage in any behaviour that could endanger yourself or others.
- 5. Waiver and Release of Liability: In consideration of being permitted to participate in the Event, you agree to waive and release any claims or causes of action you may have against the Event organizers, their officers, directors, employees, agents, and volunteers for any and all liability, damages, injuries, or losses that may occur during the Event, including but not limited to any claims arising from the negligence of the Released Parties.
