President's Report

As I look out my window this first day of May, it's beautiful with sunny skies and the lake looks peaceful. In the next few weeks the boat launch and lake will come alive with fishing boats, pontoon boats, ski boats, sail boats and jet skis. The boat ramp and the driveway to the boat launch were reconstructed and upgraded last fall by the Department of Agriculture, Conservation and Forestry (DACF) who owns the ramp/parking area. It looks great and will make it easier for watercraft to put in and out of Toddy.

These past 12 months, your Board and Outreach Committee have been consumed by the dam ownership issue. Over the course of these months, TPA has kept you up to date by sharing pertinent information in a timely manner via live Zoom meetings, emails, and post mailings. The bill to form a Toddy Pond District cleared the legislative committee workshop on May 7, and will now go to the House of Representatives and the Senate to be voted on, followed by signing by the Governor. If that happens, then, during the November town elections the District will need to be voted on and approved by the towns of Blue Hill, Orland, Penobscot and Surry. Over the Summer and Fall, TPA will be very busy informing the public about the need to pass this initiative and create the District to own and manage the dam. If anyone has suggestions for additional means to inform the membership about what is happening, please let us know.

Two valuable board members have had to step down this spring. The Board thanks John Moss and Chris Closs for their time, effort and work on behalf of TPA. They will be missed on the board and we all wish them success in their endeavors and hope to see more of them this summer on the pond.

Finally, I want to thank the group of people who have been tirelessly working to make sure that Toddy Pond stays as the pond we all love. The Board: Barry Johnson, Robin Yurkevicz, Donna Foster, Brian Smith, Phil Roberts, John Moss and Chris Closs have put in countless hours in meetings, phone calls, zoom meets and other work to get us to where we are today. Additionally, our Outreach Committee, chaired by Jeff Roth has been fantastic. The committee members Charlie Bloch, Carla Mulhern and Kevin Miller have done impressive work. They've accomplished an impressive amount of outreach and have put together useful information on the economics of the lake which we'll be sharing shortly. We owe all of these folks a ton of thanks for their work for Toddy.

Please feel free to drop us a line with any comments, questions or suggestions.

I look forward to seeing you at our summer barbecue on July 13, and then the TPA Annual Meeting on August 19. Wishing you all a fun filled and safe summer on Toddy Pond.

COURTESY BOAT INSPECTION SPRING 2025

Are you ready for another summer on beautiful Toddy Pond?

Our Courtesy Boat Inspection (CBI) program is gearing up for another season of keeping the waters of Toddy Pond free of invasive plants. Last autumn, at the end of the boating season, the Maine Department of Agriculture, Conservation and Forestry (DACF), who own the boat launch on Toddy, invested over \$100,000 to renovate and extend the concrete boat ramp and repave the part of the driveway onto Route 1 that had deteriorated over the years. The old outhouse is gone (and will not be missed) and there are two porta-potty units placed.

We are happy to have three paid inspectors for this summer; Steve Sheehan and Arnold Spahn returning, and George Atwood is re-joining our CBI crew after a couple years away. We are scheduling 6 days of paid coverage with additional coverage, as always, from our dedicated volunteers. I am currently finalizing the schedules, and getting the volunteer inspector sign up sheet active on the TPA website. New handbooks and inspection forms will be available shortly. I have CBI inspector tee shirts in various sizes for anyone new signing up, or for anyone who's old shirt has seen better days. I've updated the volunteer information sheet and will make that available to all of our inspectors.

TPA received funding from Maine DEP and the Maine Community Foundation. Additionally as he has for the past several years, William and Peggy Mitchell have graciously contributed substantially to cover the cost of our paid inspectors.

Keeping Toddy Pond free of invasives = we need committee members (one member currently) to help co-manage, as well as more volunteers.

Your willingness to get involved is more important than expertise. I will happily bring any volunteer up to speed. Please contact Marc Restuccia at Marc/CBI@toddypond.org.

Thanks - we all can contribute to keeping our pond clear and clean, and I can't wait to see all of you on the water this summer!

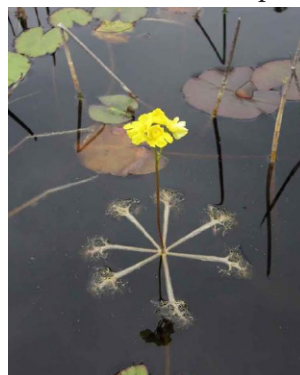

INVASIVE PLANT PATROL (IPP)

Spring 2025 Update

The water is high and cascading over the dam, a loose float or two have drifted by and mud season has passed. Other people may look for the return of robins or crocuses to signal the return of Spring, but those of us living on the pond year round watch for ice out and the return of loons. The Invasive Plant Patrol team will start the year with seven new IPPers, six of them from Blue Hill! I am very excited to have coverage for that southernmost area of our pond at last. We also need more help for the eastern shore of North Toddy in Orland and will welcome anyone interested in joining no matter where you live. If you like to kayak and spend time on the lake then consider joining our team. After a brief training session, most survey sections can be completed with about three hours of paddling at your convenience.



Most people have heard about invasive milfoil. The new invasive species in Maine is Swollen Bladderwort. Five new infestations were identified in Maine last summer - all of them Swollen Bladderwort. There are four species of native bladderwort in Toddy Pond. You may have seen Common Bladderwort in late summer, small yellow flowers protruding out of the water sitting on a star like structure. (Yes, they are pretty). While our native bladderworts flower in late summer or fall, the Swollen Bladderwort can flower at various times, including as early as June. It's also much larger than our native look-a-like. If you see this flower (picture) early in the summer it is suspect, please notify an IPPer or contact us at toddymail@toddypond.org. Courtesy Boat Inspection and IPP together are a formidable force protecting our pond, and an easy and fun way to help protect the pond we love.

Dinner at 5 PM*

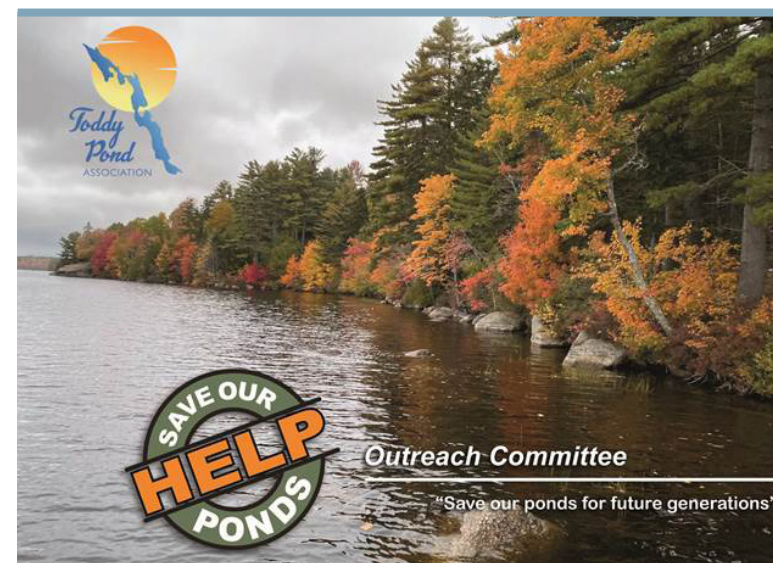
We hope that you will join us! Our events are open to all Toddy Pond members, non-members, and pond supporters.

TODDY'S LOYAL SPONSORS

He has focused on not just selling a property but finding the right buyer to preserve the local environment. He has worked with Great Pond Mountain Conservation Trust and Blue Hill Heritage Trust to acquire land for conservation to be enjoyed for future generations.

Need a place to stay on the pond or is your house overflowing with house guests? **GeTogether Stays** owner Eddie Gonnella has refurbished all the lakeside cabins he purchased in 2023. Originally built in the 1930's, each cabin has been upgraded with new furnishings, heat and air conditioning. Kayaks, fire pits and picnic tables and Adirondack chairs are available on the site.

If camping is more your style, **Balsam Cove Campground** has been hosting TPA's annual BBQ for several seasons and has kayak and boat rentals for guests.

Like to be outdoors? Blue Hill Heritage Trust is a community-based conservation organization, in existence for more than 35 years and has procured over 11,000 acres on the greater Blue Hill Peninsula. Public walking and hiking trails are located on several property areas, and hunting is welcome on most of the properties, after submitting a permission form. Do take advantage of these excellent opportunities to get outside. Chris Muise, the owner of **The Activity Shop**, in Blue Hill, told me “we are the puttering about company.” His business rents kayaks, (both recreational ones for lakes and performance kayaks suitable for ocean paddling), canoes and paddle boards. Chris will deliver the craft to your place on the lake. In the summer of 2024 Chris delivered 52 watercraft to various properties on Toddy Pond.

Pen Bay Marine in Orland provides full service for all your boating needs including repairs, winterization, launching, hauling, storage and more. They serve the area's lakes as well as ocean communities. Hannah Stevenson told me that they do a lot of mobile work and are able to do some work right at your dock.

Another business that has been sponsoring TPA for several years is **Central Maine Auction Center** in Hermon, the biggest auction company in Maine. They offer full auction services; auctioning off heavy equipment, campers, trailers, ATVs,

snowmobiles, real estate and 500 cars a week! Owners Catherine and Kevin Tilton are Orland residents and count as one of their employees a chocolate lab named Willa.

Chris Closs, of **Closs Preservation**, and former President of Toddy Pond Association, has spent 45 years consulting with communities and private entities to preserve and redevelop historic buildings, promoting new life for former mills and older buildings. Locally he managed the redevelopment of Bangor House into an apartment building in 1979 and has advised on major repairs for the Jonathan Fisher House in Blue Hill.

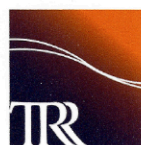

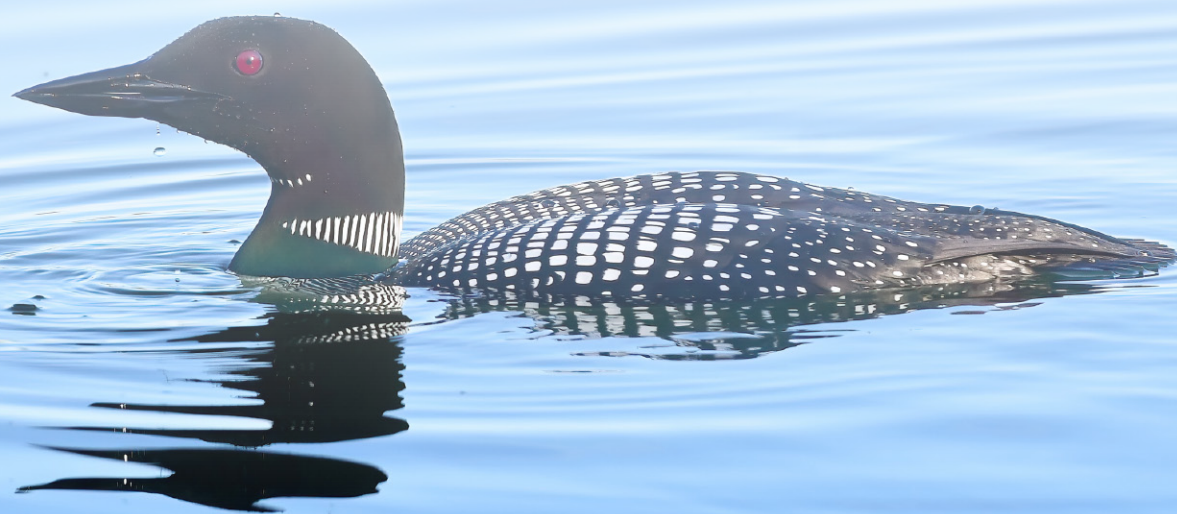
What's up with Loons?

The 42nd consecutive Toddy Pond loon count will take place on July 19 from 7-7:30 AM. Last year 22 people volunteered to cover the 14 pond sections and located 22 adults and 2 chicks, numbers consistent with previous years. Loon chicks have been subject to bald eagle predation in recent years, a major concern for the long term health of our loon population, so it was good to see two healthy chicks on count day. LOON RAFT UPDATE:

Two Summer ago, Maine Audubon partnered with volunteers from Toddy Pond to build a floating loon raft to provide additional "living quarters" - nesting sites for loons. This Spring a loon pair has been swimming near the raft, presumably assessing the property. Over this winter, the raft broke loose due to high winds and was in need of attention. Two people from Maine Audubon were here on May 5 to help refurbish the loon raft and it has again been anchored across the pond from the boat access. It looks cozy and inviting but it went unused the first two years and was still unoccupied as of this writing. Sometimes it can take several years for a raft to attract a nesting pair, so there is still hope.
