Dear Vendor,

We're excited to announce planning has started on the 2024 Sons of Italy Old Time Italian Festival! The Festival will be held at Fox Park, 4500 Ocean Avenue, Wildwood, NJ on **Friday, September 27th & Saturday, September 28th**. This package provides important information regarding vendor space availability. Please review the documents carefully and take the appropriate actions to secure your spot(s) at this incredible event.

Our Italian Festival is a two-day event. We would prefer that our vendors attend both days, however it is the individual vendor's choice. Each vendor is responsible for paying the full fee in the chart below regardless of that choice. Vendor booths will be divided into four (4) sections, Food, Merchandise, Crafts and Rides/Entertainment for the children.

On Friday, September 27th set up time starts at 8:00 am and must be completed no later than 2:30 pm. On Saturday, September 28th set up time starts at 8:00 am and must be completed no later than 10:00 am. Each vendor is responsible for the individual set up of their booth(s). Electricity is provided by the Park.

If you are a food vendor that requires a grill, stove, oven, or any type of open flame **you are required** to apply to the City of Wildwood for an OPEN FLAME PERMIT no later than 72 hours prior to the event. The fee for this permit is payable to the City of Wildwood and you can contact Wildwood Fire Prevention Dept at 609-522-2440 ext.2230. Proof of the permit must be provided to the Festival Committee.
