MARK YOUR CALENDAR for the 2025 Sons of Italy Olde Tyme Italian Festival at Fox Park, 4500 Ocean Avenue, Wildwood, NJ on Friday, September 26th & Saturday, September 27th. Please review the documents carefully! Deadlines and fees have been adjusted to comply with the City of Wildwood's new ordinances.

Our Italian Festival is a two-day event. We encourage our vendors to attend both days, however it is the individual vendor's choice. Each vendor is responsible for paying the full fee in the chart below regardless of that choice:

| Food Truck/Vendors | 20 x 10 | \$750.00 | \$100.00 | \$75.00* | \$925.00 |
| Craft/Merchandise/Food Vendors | 10 x 10 | \$375.00 | \$ 50.00 | \$75.00* | \$500.00 |

NOTE: There are two classifications of Food Vendors if you are unclear of the category that applies to your business please contact us for support.

Application/Payment Deadline: September 1, 2025 (no exceptions due to City ordinance)

- Vendor Application
- Festival Insurance Waiver and Protection Waiver form AND
- Type 1/Fire Permit (if applicable) Application

NOTE: An <u>early payment discount of \$50.00</u> should be deducted from your remittance if documents and payment are received by August 1, 2025.

IMPORTANT: Due to the new ordinances, applications/payments CANNOT be accepted after September 1, 2025, no exceptions!

Set up time on Friday, September 26th begins at 8:00 am and must be completed no later than 2:30 pm. Set-up time on September 27th starts at 8:00 am and must be completed no later than 10:00 am. Each vendor is responsible for the individual set up of their booth(s). Electricity is provided by the Park.

^{*} A Type 1/Fire Permit fee should be included if your vendor space exceeds 900 sq. ft./30 ft. in any direction OR when temporary food preparation activities require an open flame or flame-producing devices (gas, propane, sterno, etc.) or when grease-laden vapors are produced.
