- Complete SMR Course Registration.
- Complete AHA Instructor Candidate Application.
- Have current AHA BLS & ACLS Provider certification.
- Complete **ACLS Instructor Essentials Course** online.
- Complete **2025 ACLS Instructor Update Course** online.
- Confirm registration on AHA ATLAS website.
- Submit course payment.
- Successfully complete classroom portion of the ACLS Instructor Course.
- Be monitored by AHA Faculty while teaching an ACLS course. This will be accomplished on day 2 of the course.
- Submit copies of documents prior to class.

## **TRAINING CENTER ALIGNMENT:**

AHA requires instructor candidates to align with an authorized Training Center or Training Site that accepts new instructors. Candidates who complete this course shall be offered alignment with SMR upon completion of all certification requirements.

The **ACLS Instructor course** is intended to equip instructor candidates with the skills needed to teach AHA Instructor-led and blended learning classes. It covers how to effectively use AHA teaching resources, ensure students achieve learning objectives, student coaching, objectively evaluate skills performance, and adhere to AHA Instructor and course guidelines. The Instructor Essentials Course is an online, self-paced program tailored to each discipline and is managed and paid for through the AHA. The SMR ACLS instructor course bridges the gap from BLS instructor to advanced topics covered in ACLS.
