PROCESS OF BECOMING A BLS INSTRUCTOR:

- Be accepted to the SMR AHA Training Site prior to enrolling in the Instructor Course and complete Instructor Candidate Application.
- Have current AHA BLS Provider or Heartsaver certification and be proficient in all required skills.
- Prior to class, complete the BLS or Heartsaver Instructor
 Essentials Online and print the Certificate of Completion.
- Successfully complete the BLS/Heartsaver classroom Instructor Course.
- Successfully complete the AHA 2025 curriculum update.
- Be monitored by AHA Faculty while teaching a BLS/HS course. This will be accomplished during the afternoon portion of the class.
- Register and pay for the course
- Bring copies of all required documents and materials to class.

TRAINING CENTER ALIGNMENT:

American Heart Association requires Instructor Candidates to align with an authorized Training Center that is accepting new Instructors when signing up for an Instructor Course. The CPR Lady Training Center automatically aligns all Instructors who take The CPR Lady Instructor Courses and does not charge an additional alignment fee.

The BLS/Heartsaver Instructor Essentials course is designed to prepare Instructor the instructor candidate to teach AHA Instructor-led and blended learning courses, show how to adequately use AHA Instructor teaching materials, ensure that students meet learning objectives, offer student coaching skills, provide an objective skills performance evaluation, and follow AHA Instructor and course policies. The Instructor Essentials Course is an online, self-directed, and discipline-specific course. This course is administered and paid for through AHA. Candidates seeking BLS Instructor only need to complete the BLS Instructor Essentials course.

The American Heart Association is authorized to offer AMA Credit Designation Statement to Physicians, AAPA Credit Acceptance Statement to Physician Assistants, AANP Credit Acceptance Statement to Nurse Practitioners, ANCC Credit Designation to Nurses, ACPE Credit Designation Statement to Pharmacists, Continuing Education Accreditation to Emergency Medical Services for the BLS Instructor Essentials. Credits are claimed on the AHA website but there are time limits of 30 days to 6 months depending on the accrediting agency.
