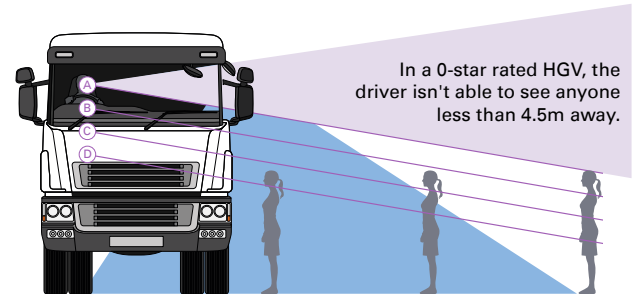
Direct Vision Standard, safety legislation from Transport for London (TfL).

WHAT IS DIRECT VISION STANDARD (DVS)?

The Direct Vision Standard (DVS) is a **Safety Legislation** from Transport for London. Its aim is to **reduce the fatality and accident rates for pedestrians & cyclists caused by HGVs**. It is an integral part of the Mayor's wider pledge: "Vision Zero by 2040".

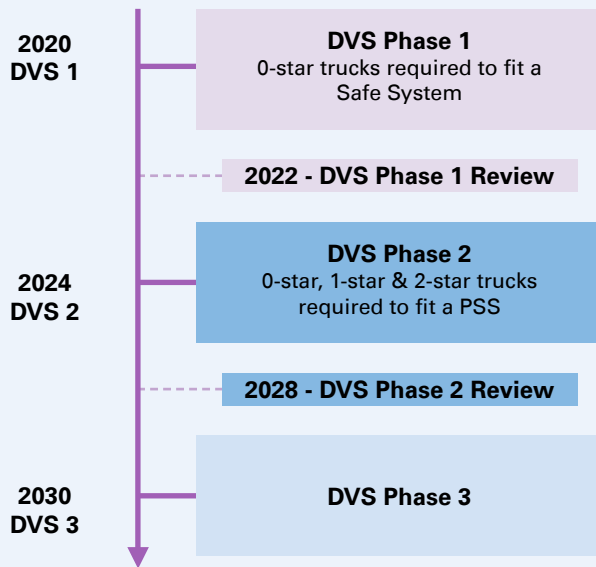
HOW DOES DVS WORK?

DVS measures a driver's direct vision through the windows of an HGV Cab. A star rating system from 0* (limited vision) to 5* (increased vision) is used to indicate the level of risk to people walking and cycling near the vehicle.



A - Zero Star | B - One Star | C - Three Stars | D - Five Stars
The star rating is based on the driver's direct vision

WHAT ARE THE DIFFERENT PHASES OF DVS?



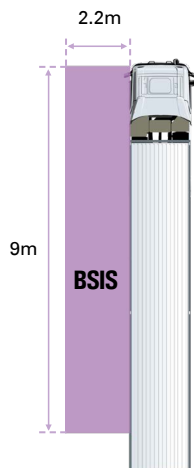
WHAT IS DVS PHASE 2?

DVS Phase 2 requires **HGVs over 12T between 0-2 stars** to have a **Progressive Safe System (PSS)** fitted to get their Safety Permit to enter Greater London.



WHAT DO I NEED TO GET MY PERMIT?

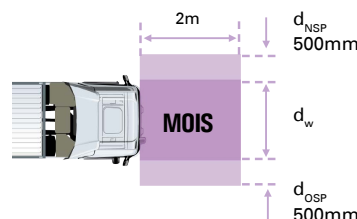
- 1 CMS to completely eliminate nearside blind spot **NEW**
- 2 Blind Spot Information System (BSIS) **NEW**
- 3 Moving Off Information System (MOIS) **NEW**
- 4 Left turn speaker
- 5 Warning sticker
- 6 Sideguards



WHAT TO LOOK OUT FOR?

Blind Spot Information System (BSIS) must cover 9 x 2.2m area down the nearside of the vehicle.

Moving Off Information Systems (MOIS) Must cover an area of 2m x (width of vehicle (d_w) + 500mm either side).



OVER 211,000

vehicles between 0- and 2-star could be affected by DVS Phase 2.

3- TO 5-STAR

vehicles already have a Safety Permit that is valid until 2030.

WHEN ARE THE DVS PHASE 2 KEY DATES?

- 24th June 2024 - DVS Phase 2 Safety Permit applications open.
- 27th October 2024 - 0-2 star HGVs Safety Permits delivered for DVS Phase 1 expire.
- 28th October 2024 - PSS required for 0-2 star HGVs.
- 28th January 2025 - 3-month grace period ends.
