

Redeem Stream's Terms of Service

Effective Date: February 1, 2025

ACCEPTANCE OF TERMS

These Terms of Service ("Terms") govern your access to and use of Redeem Stream services and sites including Redeem Stream.com, coupon clipping, digital coupon services, and related services, whether on these sites or powered by Redeem Stream technology (collectively, the "Service" or "Services"), and any information or data accessed, viewed, or downloaded during your use of the services (collectively the "Content"). By using these Services and/or accessing the Content, you agree to be bound by these Terms.

SERVICE DESCRIPTION

Redeem Stream creates, distributes, and tracks clips and redemptions of 8112 national manufacturer coupons to consumers for redemption at 8112-enabled stores in the United States only.

WHO MAY USE THE SERVICES

You may use the Services only if you agree to form a binding contract with Redeem Stream, Inc. ("Redeem Stream") and your use of the Services constitutes your agreement to such a contract. You must be at least 18 years old to use the Services. If you are accepting these Terms and using the Services on behalf of a legal entity, such as a company, organization, government, or otherwise, you represent and warrant that you are authorized to do so.

PRIVACY

- You understand that certain information may be used and stored on your device or on our systems, in accordance with the privacy policy referenced above, and you

agree not to circumvent, interfere with, or otherwise avoid such authentication technologies

- You agree not to transfer any coupon, whether through sale, barter, or otherwise, to any third party

COMMUNICATIONS

You can control most communications from us. However, we may need to send you communications, such as notifications, announcements, or administrative messages and you may not be able to opt-out from receiving them. You may opt out of other forms of communications from us, including marketing communications, at any time.

YOUR LICENSE TO USE THE SERVICES

Redeem Stream gives you a personal, worldwide, royalty-free, non-assignable and non-exclusive license to use the software to which you have access as part of the Services. This license is intended solely to enable you to use Service in accordance with these Terms. The Services are protected by copyright, trademark, and other laws of both the United States and foreign countries. Nothing in the Terms gives you a right to use the Redeem Stream trademarks, logos, domain names, and other distinctive brand features. All right, title, and interest in and to the Services are and will remain the exclusive property of Redeem Stream. In addition, nothing in the Terms gives you right to use the names or copyrighted or trademarked materials of any brand whose coupons or offers are delivered via the Service.
