Beyond Cutting: An In-depth look at Self Injury

4 Category I CEU's

This workshop will examine the various forms of self-injuries behavior that go beyond cutting. It is estimated that two million people in the United States injure themselves in some way. Various issues will be discussed including but not limited to propensity, forms of injury, risk factors, brain development, co-morbidity, nonsuicidal self-injury diagnosis and treatment modalities. This is an interactive workshop with case scenarios presented discussed. This workshop will also examine the differences and similarities between selfinjurious behavior and suicidal ideations and attempts. Participants will use current literature and case examples to explore the importance of understanding best treatment modalities.

Understanding and Exploring the Trauma of Undocumented Immigrants

This is an interactive workshop where case vignettes will be presented and discussed.

## Ethical and Cultural Issues in a Health Care Setting

This workshop will explore the numerous ethical and cultural issues that can arise in a healthcare setting. An emphasis will be placed in exploring ethical and cultural issues to enhance and improve ethical responsibilities and reduce This workshop will discuss ethical violations. common practice areas that raise ethical dilemmas and explore the code of ethics and propose various ethical decision-making models that can utilized to resolve these ethical conflicts. A focus will be on analyzing various ethical codes: Maryland Board of Social Work Examiners (Title 10, .03 & .06) to the National Association of Social Workers Code of Ethics (1.01, 1.04, 1.05 & 3.02). code of ethics, cultural Explore issues on: considerations, ethical framework model, and best practice techniques. This is an interactive workshop where cases vignettes will presented and participants will work in a group setting to further maximize their understanding of the concepts presented.
