

Information for sponsors in Europe

The Giraffe Children's Charity is a charitable company under UK charity law. It is administered by a group of Trustee Directors, based in the UK and Belgium, with representatives also in Germany and the US. The projects in Kenya are managed by our Kenyan Executive, administrators and local partners who are in regular communication with the European team.

Tax Information for European taxpayers

Several European countries have bilateral agreements for giving to registered charities abroad through Transnational Giving Europe (TGE) and The Giraffe Project is registered with TGE.

Belgian taxpayers can get tax relief by making their donation through the King Baudouin Foundation/Fondation Roi Baudouin/ Koning Boudewijnstichting (KBF). KBF will send you an 'attestation fiscale' for submission with your annual tax form.

German taxpayers have a similar system through Maecenata International.

Primary sponsorship: (single sponsor) €30/month
