#### **About B Johnson LLC**

B Johnson LLC is a the private practice of Bethany Johnson, Licensed Clinical Social Worker. B Johnson LLC is located with in the cooperative office of the Mental Health Offices at the 606 Professional building located in downtown Madison, Indiana. B Johnson LLC shares the professional space with eight other mental health professionals and supportive staff, including therapist/counselors, psychiatrist, and billing/administrative specialist. The Mental Health Offices located on the second floor/Suite 2 of the Professional Building was established by Dr.Gwen Heaton, MD to provide psychiatric and psychological services to the community. Bethany Johnson, LCSW was invited to this cooperative in October 2021 and began practicing at this location in January 2022 working with Adult, Children, Families/couples in Jefferson county and surrounding communities. Prior to 2022 Bethany Johnson, LCSW worked in the area as a clinical social worker in community mental health organizations starting in July 2016 after graduating with a Masters of Science in Social Work. During this time Bethany was able to complete the required training and supervision to become an independently licensed clinical social worker and reputation as dedicated and competent social worker.

Per the Requirements of the No Surprises Act of 2021, individuals who are self-pay (as in those who are not insured or elect to not utilize federal insurance programs or private health insurance) have the right to be provided with a Good Faith Estimate (GFE) identifying the cost associated with services. It is important that GFE's are provided within one business day following the initial assessment, and within three days of session scheduled ten days or more out. B Johnson LLC provides GFE for the first three months of services in which the standard arrangements is one session per week for the first 8 weeks and one session per two weeks following. After which clients/guardians may request an updated EFT for future services. If there are any changes to services/billing a new GFE can/will be issued. In the event of Billing exceeding more than \$400 of the EFT, a client has the right to dispute the bill. For those who are insured privately Good Faith Estimates are provided to health insurance companies. For those individuals who are insured via federal health insurance programs such as Medicaid, Medicare, Tricare etc, other no surprise protections are in place such that B Johnson LLC as a provider cannot exceed those amounts identified agreed to within the provider agreement with the respective federal programs. The establishment and clarifications of rule regarding this are ongoing and clients will be updated as new or changing regulations are made.

- Cease any and all services without reason or cause

# Confidentiality in regard to alcohol and drug abuse records

The confidentiality of alcohol and drug abuse client records maintained by B Johnson LLC and The Mental Health Offices is protected by Federal law and regulations. Generally, B Johnson LLC may not disclose the involvement of any client in a alcohol or drug abuse program to anyone outside the program unless:

- The client consents in writing,
- The disclosure is allowed by a court order, or
- The disclosure is made to medical personnel in a medical emergency or to qualified personnel for research, audit or program evaluation.
- Disclosure in the course of Dept of Child Services Investigation specific to suspected child abuse

Violation of the Federal law and regulations by the program is a crime. Suspected violations may be reported to

appropriate authorities in accordance with Federal regulations.

Federal law and regulations do not protect any information about a crime committed by a client either at the program or against any person who works for the program or about any threat to commit such a crime.

Federal laws and regulations do not protect any information about suspected child abuse or neglect from being reported under State law to appropriate state or local authorities.
