### School report by Margie Gabiola

## 1. Auction

- d. 70's theme to mark 70th anniversary

### 2. Preschool

- a. Pre-K has 3 children on waitlist
- b. Several families currently taking tours and expressing interest in the school
- c. School is wanting to hire preschool teacher
- d. Five 3-year-olds currently enrolled and are in combined class with 4-year-olds
- e. Hiring a new teacher would allow an individual 3-year-old class
- f. Current teachers: Cristella and Stacy and Brandelia as CPI three days a week

### 3. Strategic Plan
