# **Qualifications for Participation**

All legal and qualified voters of the 90<sup>th</sup> House of Delegates District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Each voter shall meet the requirements as specified in the Call (see attached). Each voter shall present a government issued photographic identification.

All participants in the canvass will follow COVID 19 Related guidelines issued in Executive Order 63 to include face coverings and social distancing.

## **Filing Requirements**

Candidates for the Republican nomination at said canvass shall file a written statement delivered in person, to Daniel H. Haworth, 90<sup>th</sup> District Republican Chair, 1414 Killam Ave, Norfolk, VA 23508, which must be presented, along with identification in the form of a Virginia driver's license, or government issued picture ID not later than 5 p.m. on Tuesday, December 1, 2020. If only one qualified candidate properly files, then said candidate shall be declared the Republican nominee and no canvass will be held. Filing shall be in the form of a letter, addressed and presented to Chairman Haworth at the address above. The letter shall indicate that the candidate seeks the nomination as the Republican Candidate for 90th District, House of Delegates and shall state that the candidate is a resident of, and registered to vote in, the 90th District, and that he/she intends to support the nominee of the Republican Party in the general election for the 90th district House of Delegates seat. A check in the amount of \$300.00, non-refundable, made payable to the Republican Party of Norfolk on behalf of the 90th District Committee, shall accompany the filing.

There will be no registration fee to vote in this canvass.
