OPEN TO JUNIOR RIDERS. FENCE HEIGHT MAY BE COMBINED WITH ADULT HUNTER IF ENTRY'S WARRANT. EACH HEIGHT WILL RUN SEPARATELY IF ENTRIES WARRANT OR MAY BE COMBINED.

M&S / PEL CHILDREN'S PONY MEDAL, NOT TO EXCEED 2',2'6"-OPEN TO JUNIORS AND AMATEURS.

M&S/PEL CHILDREN'S HUNTER CLASSIC, NOT TO EXCEED 2',2'6" RUNS WITH THIRD HUNTER CLASS RIDERS MUST BE AMATEURS. TWO-ROUND CLASSIC. HORSE OR PONY MUST HAVE ENTERED, SHOWN AND COMPLETED THE COURSE IN TWO HUNTER OR EQUITATION CLASSES OVER FENCES AT THE SAME SHOW.

**BABY GREEN HUNTER, PEL NOT TO EXCEED 2'-**OPEN TO ANY HORSE IN ITS FIRST 2 YEARS OF SHOWING. NO OXERS. TROTTING NOT PENALIZED.

#### CLASSES 1, 234 PEL

MINI STIRRUP EQUITATION, NOT TO EXCEED GROUND POLES - OPEN TO JUNIOR RIDERS 10 YRS. OF AGE & UNDER. RIDERS MAY NOT HAVE COMPETED MORE THAN 1 TIME IN A CLASS REQUIRING THEM TO CANTER. CLASS 5, 6, 7, 8

Walk Trot Equitation, not to exceed Ground Poles - Open to Junior & Amateur riders 11 years of age & over. Riders may not have competed more than 1 time in a class requiring them to canter. Classes 9, 10, 11 12 PEL

**BEGINNER RIDER EQUITATION, 11 YRS AND UNDER NOT TO EXCEED 18"**— OPEN TO JUNIOR RIDERS 11 YEARS OF AGE & UNDER WHO HAVE NOT SHOWN BEYOND CROSS RAILS. TROTTING NOT PENALIZED. CANTERING IN ONE AT A TIME. FENCES: CROSS RAILS WITHOUT FILLERS, UNDER 18".

#### CLASSES 13, 14 15, 16 PEL

**BEGINNER RIDER EQUITATION, 12 AND OVER NOT TO EXCEED 18"**- OPEN TO JUNIOR & AMATEUR RIDERS 12 YEARS OF AGE & OVER WHO HAVE NOT SHOWN BEYOND CROSS RAILS. TROTTING NOT PENALIZED. CANTERING IN ONE AT A TIME. FENCES: CROSS RAILS WITHOUT FILLERS, UNDER 18".

# CLASSES 17 18 19 LEAD LINE EQUITATION, PEL NOT TO EXCEED GROUND POLES - OPEN JUNIOR

RIDERS 9 YEARS OF AGE AND UNDER. RIDERS MAY NOT HAVE COMPETED OFF THE LEAD OR IN ANY OTHER CLASS/DIVISION AT ANY SHOW. LEADER AND SIDE WALKERS MUST BE OVER THE AGE OF 14 AND APPROPRIATELY DRESSED.

CLASS 20 SHINNY HINNY 50/50 PAYBACK SCHOLARSHIP CLASS— JUDGED IN HAND WITH HALTER AND LEAD. HORSES WITH BE JUDGED BASED ON THE BEST GROOMED. \$25.00 PER ENTRY WILL BE ADDED TO THE PRIZE PURSE. 50% OF THE PRIZE PURSE GOES TO THE WINNER OF THE CLASS AND THE OTHER 50% WILL BE COLLECTED THROUGHOUT THE SHOW YEAR AND ADD TO THE HVHS SCHOLARSHIP FUND.

**SHORT STIRRUP EQUITATION PEL NOT TO EXCEED 18"**- OPEN TO JUNIOR RIDERS 12 YEARS OF AGE AND UNDER AS OF DEC. 1ST OF THE CURRENT SHOW YEAR. TROTTING NOT PENALIZED.

#### CLASSES 25 26 27 28

**LONG STIRRUP EQUITATION, 18"—** OPEN TO JUNIOR AND AMATEUR RIDERS 13 YEARS OF AGE AND OVER. TROTTING NOT PENALIZED.

**CROSS RAIL HUNTER, PEL 29, 30, 31, 32,** OPEN TO ALL RIDERS AND ALL HORSES NOT TO EXCEED 18" CROSSRAILS, TROTTING NOT PENAILIZED

**CROSSRAIL JUMPERS, PEL.18" 33, 34, 35** OPEN TO ALL RIDGES AND ALL HORSES NOT TO EXCEED 18" CROSSRAILS, TROTTING NOT PENALIZED.

**PRE SCHOOLING HUNTER 18"** OPEN TO ALL RIDERS AND HORSES NOT TO EXCEED 18" STRAIGHT RAIL

Open to horses & ponies ridden by riders of ANY age. Fences LESS THAN 2' in height. Section A: Rider may not have shown in a division, at any show, where the fence height specifications are 2' or higher. Riders in section A may not cross enter in any division or class at any competition where fences are 2' or higher. The rider will be no longer eligible for Beginner's. Section B: Horse or pony not to have shown in a division, at any competition, where fence height specifications are 2' or higher. Horses may not cross enter into any division or class where fences are 2' or higher at the same competition.

MODIFIED EQUITATION 18", 36-39 OPEN TO AMATUER RIDERS, NOT TO EXCEED 18" STRAIGHT RAIL OPEN TO EXHIBITORS OF ANY AGE WHO HAVE NOT SHOWN IN A DIVISION, AT ANY SHOW, WHERE THE FENCE HEIGHT SPECIFICATIONS ARE 2' OR HIGHER. TO BE SHOWN OVER A COURSE LESS THAN 2'. RIDERS MAY NOT CROSS ENTER INTO ANY OTHER DIVISION OR CLASS WHERE FENCES ARE 2' OR HIGHER. TROTTING ON COURSE NOT TO BE PENALIZED, ALTHOUGH AN UNINTENTIONAL BREAK OF GAIT WILL BE PENALIZED.
