

**CONSENT FORM - TIARAS AND TALES**

By signing below, I agree to the following terms and conditions:

1. **Clothing:** I understand that my child may not be allowed to participate in dress-up activities if my child is not properly attired. Proper attire is a tank top and shorts or leggings, tight fitting top, or leotard. All costumes and accessories remain the property of Tiaras and Tales; however, some may be available for purchase.
2. **Potty Training:** I verify that my child is potty trained and agree that I will remain on the premises for the duration of the play session if my child is not potty trained.
3. **Illness and Behavior:** I agree that, in the event my child becomes ill while at Tiaras and Tales, or if I am notified that my child is misbehaving, violent, or disruptive of the play session, I will pick up my child within 30 minutes of being notified.
4. **Video and Photographs:** To ensure the safety of the children and staff, cameras are placed throughout Tiaras and Tales and will record all play sessions. I give Tiaras and Tales permission to post pictures of my child on the "Tiaras and Tales" social media pages for promotional purposes.
5. **Health Policies:** I have notified Tiaras and Tales of all of my child's medical conditions. I warrant that my child has no infectious, contagious, or communicable sickness. I authorize Tiaras and Tales to administer simple first aid as reasonably appropriate for minor surface injuries. In case of an emergency, I authorize Tiaras and Tales to call emergency medical services and give authorization for emergency medical treatment.
6. **Allergy Awareness.** Although Tiaras and Tales provides pre-packaged, nut-free snacks according to packaging, I understand that it is my obligation to notify Tiaras and Tales of my child's known allergies. While Tiaras and Tales uses face paint, makeup, and nail polish deemed nontoxic according to packaging, it is my responsibility to notify Tiaras and Tales of my child's known allergies to certain products.
7. **Indemnity:** I agree to indemnify, defend and hold harmless Tiaras and Tales, its owners, agents, and employees, from and against claims, damages, losses, and expenses, including but not limited to attorney's fees, arising out of or resulting from the actions or omissions of me and/or my child(ren), my agents, family members, and other related parties, including but not limited to failing to comply with these terms and conditions.
8. **Release:** I, on behalf of myself, my spouse, and each child designated on this Consent Form, waive and release all rights, causes of action and claims against Tiaras and Tales, LLC, and its owners, agents, and employees, for any and all loss of or damage to property or injuries suffered by my child during the time my child is at Tiaras and Tales, including the possible negligence of Tiaras and Tales, but excluding gross negligence and intentional misconduct. Tiaras and Tales provides a fun and safe environment for children and all products used by Tiaras and Tales are non-toxic according to packaging. However, there is always a risk of physical injury when playing with other children and unknown reaction to skin products, and I understand that by signing this release, I engage Tiaras and Tales at my own risk.
9. **Checkout.** Children will only be released to the individual who dropped them off or person authorized by that individual during the drop-off upon showing of photo ID. I agree that I will notify Tiaras and Tales if someone other than myself is picking up my child. I agree to relay to the authorized person that they must present photo identification or my child will not be released to them. I agree to collect my child at the end of the session, camp or party or be subject to a late pick up fee of \$1.00 per minute over the pick-up time.
