VDFP Fire Inspector 1031 Recertification Training Presenter:

The class replaces the VDFP-NFPA 1403 Compliance Officer program.

Communications, Tactics & Command Presenters: Joe & Jeff Bailey

To groom company grade officers to relinquish the incident scene to a command level officer (CLO) without it being a clustered, disorganized, and chaotic mess and to update current command level officers with sound principles of incident scene management. Eliminate a dreaded goal that so many departments often reflect and appear satisfied with: "The fire went out and no one got hurt"

Knowledge Objectives:

1. Identify fundamental fireground responsibilities to promote success right out of the gate
2. Identify basic principles of tactical decision making based on modern fire dynamics.
3. Describe the functional method for incident scene communications that provides clarity & eliminates confusion

Volunteer Recruitment & Retention Best Practices

Forestry Grant Opportunities for Your Department

Grant programs being covered will include the Virginia Dry Hydrant grant program, Volunteer Fire Assistance grant program, Wildfire Hazard Mitigation grant program, and Community Wildfire Defense Grants.

What is the Pipeline Emergency Responders Initiative (PERI) and how can it better prepare your department for a pipeline incident?

The Pipeline Emergency Responders Initiative (PERI) was conceived as a way to strengthen relationships among the various stakeholders involved with pipeline safety and emergency response, as well as to spur the development and implementation of enhanced pipeline emergency response training. Some of the ways that this will be done are to:

- * Describe basic pipeline operation.
- * Identify pipelines in the student's jurisdiction.
- * List the applicable "key players" when involved in a pipeline emergency.
- * Identify the steps in the Pipeline Emergency Response Guidelines.
- * Discuss the considerations of a pipeline emergency response event.

With the guidance of US DOT PHMSA, the hope is to implement a standardized Statewide training program for all emergency response agencies in the Commonwealth. Learn how you, your department, and pipeline operators can help establish this effective program in Virginia, and learn a little about pipelines you may have in your community.

"Fueling Success: Ignite Your Fire Department Grants Game" Fri. 8:00 am – 12 pm

In this comprehensive fire department grants class, participants will gain a thorough understanding of the intricacies and strategies involved in securing funding for their fire departments. From federal grants to local and private sources, this course covers it all. Through interactive sessions participants will learn how to identify grant opportunities, effectively plan and develop grant proposals, navigate the application process, and maximize their chances of success. Key topics include grant research techniques, budgeting and financial planning, grant writing best practices, and post-award management. By the end of the class, attendees will

possess the basic knowledge and skills needed to pursue and secure vital funding to support their firefighting operations, equipment acquisition, training programs, community outreach initiatives, and overall department sustainability.

The Good, the Bad, and the Ugly of Leadership

It is drawn from a mix of experiences with leaders that one will attempt to emulate, and those that one will do their best to avoid repeating. This presentation will cover the valuable lessons the speaker has learned (sometimes the hard way) and will provide participants with concepts and principles to address conflict, coaching and providing clear expectations.

"A Leadership Guide to Cancer"

As the fire service continues to experience an unimaginable increase of occupational cancer diagnosis within our ranks, as a supervisor, leader or co-worker you are likely in a place of discomfort in your support efforts. A cancer diagnosis not only affects the individual, but it can also have a profound effect on you professionally and personally. Receiving a diagnosis of cancer is devastating in all rights and should not be compounded by a lack of empathy from a department leader, supervisor or co-workers. Most organizations and supervisors are not prepared for dealing with a firefighter who has received a cancer diagnosis. This is a difficult time for that firefighter as you guide them through many challenging days. As a supervisor you simply might not have all the answers needed nor the direction required to provide assistance. This presentation will provide you a basis of what to say and not say, how to react, how to offer support and how to coordinate assistance.

DRIVE SMART Virginia – Traffic Safety

Fit for Duty, Fit for Life: Firefighter Physicals and the Volunteer Fire Service

Firefighters do a dangerous job and face many risks. To mitigate these risks, firefighters should be in top physical condition and participate in occupational health screenings. This course discusses the importance of firefighter physicals, provides an overview of the options available to departments, and demonstrates how firefighter physicals save lives.

Lithium-Ion Battery Response Considerations

Lithium-ion batteries have seen a steady increase in use and popularity over the past decade, and there is more to come. The most visible use of these types of batteries is in electric vehicles due to several high-profile incidents. This is concerning and needs to be addressed, but electric vehicle incidents are only a component of what the fire service needs to know since they make up only a small component of these types of fires

The course offers response considerations concerning many types of lithium-ion battery fires, from small cell phone batteries all the way up to stand-alone storage buildings. Exposure will include strategies, tactics, and tools that should be considered. With this investment of time, you can get the training to help be prepared to help be prepared to keep you and your team safe.

Roadway Incident Safety & Survival for Fire & EMS

Prepare students to establish or improve their fire department's response to roadway incidents to prevent line-of-duty deaths and injuries. This class will also prepare attendees to develop training plans and deliver training in their FD to address this hazard. 1) Students will be able to list and describe strategies & tactics for protecting personnel, victims & other nearby motorists from "D" drivers. 2) Students will be able to describe how to properly position emergency vehicles at roadway incidents to protect firefighters, EMTs, and incident victims from "D" drivers. 3) Students will be able to describe the core elements for fire & EMS departments to train for and implement a professional response to roadway incidents that should be in use in their own department. 4) Students will be able to identify various training resources and materials for roadway incident response training to carry back to their individual departments.

I'm in Charge - Roles and Responsibilities of Fire Service Leaders **Fri.10:30 am –12:00 pm**

Integrating Heavy Wreckers into Rescue Incidents

Vehicle accidents involving large trucks and buses are becoming more frequent and fire-rescue personnel are ill-prepared and trained to meet this unique challenge. One way of dealing with large transportation vehicle accidents is to involve the use of heavy wreckers and collapse-rated rescue equipment. This 3-hour course teaches rescuers how to interface with towers and better understand how their commercial heavy wreckers can help turn accidents that took hours in the past to mitigate into minutes. The classroom teaches rescuers the physics and limitations behind using heavy wreckers for rescue incidents, and a review of heavy rescue lifting equipment limitations and proper use.

Behavioral Health in the Fire Service
